

Whereas, a complaint was made by Sh. Partap Singh S/o Sh. Karan Singh, Gali No. 4/11, Near Jaali factory, Patel Nagar, Rathdhana Road, Sonapat against Sh. Jagbir Singh, Lecturer Mathematics, DIET, Panipat for mis-utilization of house construction loan of Rs. 9,85,000/- taken by him and three other namely Sh. Jagbir Singh Ghanghas, Lecturer History, Sh. Tejender Singh, Lecturer English, Sh. Ajmer Singh, Assistant, DIET Panipat from the department vide office order No. 1/1577-11 A&A (4) dated 25.10.2013.

The SCERT, Gurgaon, Haryana was requested vide this office letter No. 16/11-2016 PGT-I (1) dated 16.09.2016 for conducting inquiry into the complaint. The Inquiry Officer has concluded as under:-

"The inquiry report was sent vide this Council memo No. A-3/2016/68 dated 15.02.2016 in which in last paragraph of this report on page No. 2-3 the following remarks has already been given after proper inquiry made on the basis of documents, evidence which were produced by concerned during the inquiry process, in this report the remarks were given against concern officer/official as given below:-

1. Sh. Jagbir Singh Arya, Lecturer Math, DIET Panipat has not produced proper utilization certificate of loan amount taken from Govt. hence it shows the deficiencies in the matter.
2. Sh. Jagbir Singh Ghanghas, Lecturer History, DIET Panipat has mis-utilized the loan amount taken from Govt. against rules.
3. Sh. Tejender Singh, Lecturer English, DIET Panipat has utilized the loan amount under rules.
4. Sh. Ajmer Singh, Assistant, DIET Panipat has utilized the loan amount under rules.

So, it is clear that Sh. Jagbir Singh Arya, Lecturer Math and Sh. Jagbir Singh Ghanghas, Lecturer History, DIET Panipat shown at Sr. No. 1 & 2 above have not used the loan amount as per rules of the Govt. on the basis of documents, evidence."

Keeping in view the finding of the inquiry report facts & circumstances of the case, it is brought out here that the Enquiry Officer has not done inquiry thoroughly and the benefit of doubt goes in favour of Sh. Jagbir Singh. Moreover, from the cursory reading of the inquiry report there is no evidence to show that the Enquiry Officer had also called the complainant in the inquiry and cross examined him in front of Sh. Jagbir Singh Arya, which was all the more essential. The Enquiry Officer also did not enquire whether the complainant was genuine and the complainant was real or anonymous. All

this was mandatory, which did not happen during the course of inquiry. Thus, the inquiry report is half baked and no clear picture emerges except that Sh. Jabir Singh has not utilized the loan according to inquiry report. The relevant point in the case is that office did not ask Sh. Jagbir Singh Arya to submit the interim documents & evidence to prove that the house had partially been constructed before releasing one after the other loan installments. Further, the deductions of the loan amount is regularly being realized from the pay of Sh. Jagbir Singh and he has not put the flat exchequer to any financial loss by way of embezzlement etc.

Keeping in view relevant record of the case, a warning to be more careful in future for this obvious lapse on his part is hereby issued upon Sh. Jagbir Singh Arya, PGT Mathematics, DIET, Panipat. However, if it, comes to the notice of the office against him in this regard at later stage to prove the irregularity then he will be hauled up as per Government rules and regulations.

TERMS & CONDITIONS:-

1. This permanent Recognition is granted that on the subject to the condition that the documents/information furnished by the school authorities are factual and not devoid of truth in any way. However, if any information at any stage, is found contrary to the facts the recognition would be revoked forthwith.
2. The school shall follow the course of study as per syllabus prescribed by the affiliated board.
3. The school shall charge fees and funds as declared to the appropriate authority at the time of application for recognition and display the same on the notice board of the school and shall not increase the fees during the any academic session. In case of any change in the fee structure the school shall inform to the appropriate authority in the month of January for the next academic year and will also issue printed receipts of fees/funds to the students.

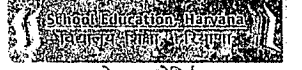

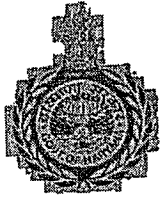

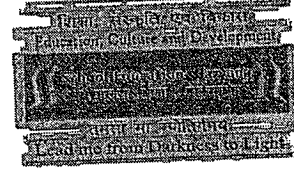

- Concerned DDO is also requested to update and approved MIS data of the official at your own level.


