ORDER

Consequent upon the orders dated 09.05.2016 passed by the Hon'ble High Court in CWP No. 24096 of 2015 titled as Hero Singh Vs. State of Haryana & others and on the recommendations of Haryana School Teachers Selection Board, Panchkula (HSTSB), Sector-2, Panchkula conveyed vide their Memo No. 2/1/13-HSTSB/2013/CA dated 02.05.2013, the Governor of Haryana is pleased to appoint **Sh. Hero Singh S/o Sh. Madan Singh, House No. 95, Type-1-B, Vidyut Nagar, Hisar** as Post Graduate Teacher (PGT) in Commerce (HES-II) in the pay band of Rs. 9300-34800 + Grade Pay 4800/- plus usual allowances as admissible from time to time w.e.f. **14.12.2013** and also allowed notional benefits from his date of appointment to his actual date of joining which would include the benefit of pay fixation, increments, seniority and all other consequential benefits. He is directed to join at the temporary place of posting as mentioned below:-

Terms and conditions:

1. The benefit of ante-date appointment w.e.f. **14.12.2013** will be admissible to him only for notional pay fixation and seniority and actual financial benefits will be admissible to him from the date he joins duty as **PGT Commerce**.
2. He is appointed purely on temporary basis. This appointment is against temporary post and her confirmation against substantive post shall be considered on the basis of her seniority and record of service as and when such post is available.
3. He shall have to take an oath of allegiance to the Constitution of India.
4. In case he is married, he shall produce a certificate, before joining duty, to the effect that he has only one living spouse. If he has more

- than one living spouse, he shall be eligible for appointment to the post offered only after the Government is satisfied that he has special ground for doing so, and exempt him from this condition.
5. He shall not be allowed to apply for any post outside the department for a period of at least five years.
 6. He shall not claim seniority on the basis of this order. His inter-se seniority will also be decided in accordance with the relevant service rules and instructions of the State Government issued from time to time later on.
 7. He shall be on probation for a period of two years. The period of probation can be extended for a period not exceeding one year, if considered necessary.
 8. In the matters, not specifically mentioned in this communication, he shall be governed by the Punjab Civil Services Rules as applicable to Haryana Government Employee and such orders/ instructions as may be issued by the Government from time to time.
 9. In case of reserved category candidate, the appointment is provisional and is subject to verification of the Scheduled Castes/ Scheduled tribes/Backward Class, and ESM Category Certificate. If the verification reveals that the claim of belonging to SC/ST/BC and ESM, as the case may be, is false then her service will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under provisions of the Indian Penal Code for production of false certificate.
 10. Candidate is hereby directed to produce her original certificates of academic qualifications, and other relevant certificate to the District Education Officer concerned alongwith photostat self- attested copies. DEO is directed to compare the photo copies with the original and thereafter original certificates and testimonials will be returned to the candidate.
 11. Medical fitness certificate issued by the concerned Civil Surgeon will be produced before the joining. District Education Officer will also give character and antecedent verification forms to him and after filling the form, the candidate would submit it to the District Education Officer concerned immediately.

12. He shall be governed by the Haryana State Education School Cadre (Group-B) Service Rules-2012.
13. If at any time during the course of his temporary appointment, he desires to resign, then in such eventuality, he shall be required to give one month's notice or forfeit, in lieu thereof, his one month's salary including allowances etc.
14. No TA/DA will be admissible to the candidate for joining as PGT.
15. If he gets an appointment as PGT on the basis of his furnishing ineligible/invalid qualifications, false/forged or fraudulent information / facts which are detected later on, he would be liable for termination of service without any notice.
16. In case, he has not passed STET/HTET and B.Ed. as yet, he shall have to qualify HTET and B.Ed. by not later than 1st April, 2018, otherwise his appointment shall stand terminated automatically without giving any further notice.
17. The appointment will be subject to the final outcome of SLP No 7820 of 2013 and other connected SLPs pending for adjudication in the Hon'ble Supreme Court of India, CWP No 18693, 20344, 17656 of 2012 pending in Hon'ble Punjab and Haryana High Court.
18. The appointment will be subject to the condition of good moral character as the verification report is awaited from the District Magistrate, **Hisar** and Superintendent of Police, **Hisar**.
19. If he is willing to accept this offer of appointment as PGT, HES-II (School Cadre) on the above terms and conditions, he should submit his joining report as per aforesaid directions.

20. He is directed to join his place of posting upto 03.03.2017 and send the joining report (duly signed by DDO) at dsepgt1@gmail.com, failing which this offer of appointment letter will be deemed to have been withdrawn.

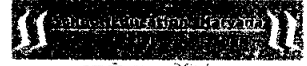

In exercise of the powers conferred upon me under rule 34(1) of Haryana School Education, Rules, 2003, sanction is hereby accorded for permanent recognition to Newton Public School, Manas Road, Kaithal run by Managing Committee, Guru Dakash Parjapati Shiksha Samiti, Kaithal for classes 9th to 12th in subjects of (Arts, Commerce & Science Stream) under BOSE pattern with effect from 01.04.2016 under the following terms and conditions:-

TERMS & CONDITIONS:-

1. This permanent Recognition is granted that on the subject to the condition that the documents/information furnished by the school authorities are factual and not devoid of truth in any way. However, if any information at any stage, is found contrary to the facts the recognition would be revoked forthwith.
2. The school shall follow the course of study as per syllabus prescribed by the affiliated board.
3. The school shall charge fees and funds as declared to the appropriate authority at the time of application for recognition and display the same on the notice board of the school and shall not increase the fees during the any academic session. In case of any change in the fee structure the school shall inform to the appropriate authority in the month of January for the next academic year and will also issue printed receipts of fees/funds to the students.
4. Salary shall be paid as per declaration at the time of seeking recognition.
5. No capitation fee and other charges shall be charged from the children/parents.
6. School shall be open for admission without any discrimination based on religion, caste, race, place of birth any other whimsical.
7. Managing Committee shall not allow to run two schools affiliated by different board/council in the same premises.
8. Managing Committee shall not close down the school or and existing class during the academic session without the prior approval of the Appropriate authority.
9. The school shall be open for inspection for the inspecting officer authorized by the Director/Appropriate Authority.
10. Recognition so granted shall be reviewed after every 10 years.
11. No financial assistance shall be granted by the Department to the school.
12. School premises shall not be used for commercial purpose and anti National activities.
13. Approval of Managing Committee shall be obtained from the appropriate authority in case of any change in the committee.
14. The Managing Committee shall follow the instructions issued by Government/Director from time to time and supply the information to the Govt./Department as required.
15. In addition to above the Managing Committee shall abide by the provisions of Haryana School Education Rules, 2003 and amendments if any thereafter. The Managing Committee shall be liable for disciplinary action in case of violation of any provisions of the rules.
16. School will provide ramp within six months otherwise recognition will stands withdrawn.
17. If any information, at any stage found Contrary to the Facts the recognition would be revoked forthwith.
18. That the number of students in classroom shall not be more than the students calculated on the 10 square feet per student for secondary and Senior Secondary Schools and 9 Square feet per student of elementary state.
19. The managing committee shall abide by the provisions of Haryana School Education Rules 2003(amended) & R.T.E. Rules 2011 and amendments if any thereafter. The Managing shall be liable for disciplinary action in case of violation of any provision of the rules.
