

7. Consent/affidavit of the official be taken that he is willing to loose his seniority in case of requested transfer orders.
8. The official will be update their profile in MIS Portal when he/she join/relieve from his/her present working station and also supply the information to the Directorate within three days positively.
9. Concerned DDO is also directed to update and approved MIS data of the official at your own level within three days positively.
10. With condition that the official is not joined previous place of posting.

Whereas by way of filing CWP No. 19856 of 2016, titled as Vijay Kumar versus State of Haryana & others, the petitioner prayed for issuance of a writ in the nature of certiorari to get quashed impugned transfer order dated 17-09-2016 alleging therein that the impugned order of transfer qua petitioner is contrary to clause-6(i) of the State Teacher Transfer Policy, 2016. The said writ petition came for hearing before Hon'ble Court on 23-09-2016 and after hearing the counsel for the petitioner at length, the Hon'ble Court pleased to dispose of the same. The operative part of this judgment is reproduced here for ready reference:


"Having heard counsel for the petitioner at length, this Court is of the considered view that the grievance of an employee as regards transfers and based upon terms and conditions contained in a Transfer Policy are required to be agitated before the employer/competent authority in the first instance.

Accordingly, the instant petition is disposed of in terms of granting liberty to the petitioner to approach the Director Elementary Education, Haryana directly as regards his grievance against the impugned transfer.

In the eventuality of any such representation being filed, the Director Elementary Education, Haryana would be obligated to consider the same and to take a final decision thereupon within a period of 07 days from the date of submission. As an interim measure, it is directed that status quo as regards place of posting of the petitioner as it exists today shall be maintained for a period of 10 days."

In the light of judgment dated 23-09-2016, the representation dated 21-09-2016 as submitted by the petitioner has been considered in the light of the provisions of State Teacher Transfer Policy, 2016 and Haryana Primary School Education (Group C) District Cadre Service Rules, 2012, following facts came into existence:-


1. That it is an admitted fact that the service under State Govt. is not a civil contract. An employee has to abide by the Statutory Service Rules; therefore, the claim of petitioner is adverse to provisions of Rule-12. In this regard, Rule-12 of the Haryana



Primary School Education (Group C) District Cadre Service Rules, 2012 says as under:

12. Liability to serve:

- (1) A member of the Service shall be liable to serve at any place, whether within or outside the State of Haryana, on being ordered so to do by the appointing authority.
- (2) A member of Service appointed by the direct recruitment on contract basis shall be liable to serve for a continuous period of five years in the rural area from the date of appointment.
- (3) A member of Service appointed by promotion or by transfer shall be liable to serve for a continuous period of three years in the rural area from the date of such appointment, if not already served for a period of fifteen years in the rural area.
- (4) A member of the Service may also be deputed to serve under,-
 - i. Pay, leave, pension and other matters. Discipline, penalties and appeals; a company, an association or a body of individuals whether incorporated or not, which is wholly or substantially owned or controlled by the State Government, a municipal corporation or a local authority or university within the State of Haryana;
 - ii. the Central Government or a Company, an association or a body of individuals, whether incorporated or not, which is wholly or substantially owned or controlled by the Central Government;
 - or
 - iii. any other State Government, an international organization, an autonomous body not controlled by the Government, or a private body:



Provided that no member of the Service shall be deputed to serve the Central or any other State Government or any organization or body referred to clause (ii) or clause (iii) except with his consent."

Perusing the contents of Rule-12 (supra), the petitioner is liable to serve at any place in the District. He has no locus standi to claim posting at the nearest school of his residence.


2. That the teachers who are members of State Cadre and District Cadre are liable to be transferred anywhere in the State and anywhere in the District respectively, at any point of time. Moreover, it has been specifically defined in the policy that the transfer/posting to the opted zone/school will not be claimed or treated as a matter of right. Every teacher had to submit its option of schools on transfer portal and confirm it. In the present case, the petitioner submitted option the schools but failed to get himself transferred at opted schools. The petitioner has given posting under transfer policy by the Computer on the basis of his composite marks. The posting of the petitioner has been considered on the basis of composite marks "Zone Wise" by the Computer itself. Since the petitioner participated in the transfer drive, therefore, he has allowed posting against vacancy available in the District. The petitioner has never been transferred elsewhere in violation of provisions of "Transfer Policy, 2016". Since the petitioner has not opted to keep continuity of service in Zone-7 carefully as defined in clause-8(ix) of Transfer Policy, 2016, resultantly, it is the computer which has to allot posting stations on basis of composite marks. In remark after transfer, it has been mentioned that the employee has successfully allocated school within his opted schools in District automatically, therefore, it is wrong to state that a teacher with less composite marks has been allocated same Block. The present transfer is a result of petitioner's own negligence for that he is not entitled to blame others.
3. That the petitioner was initially appointed on post of JBT teacher on 10-09-2008 at Govt. Primary School Patherwa, District- Mahendergarh, a District Cadre post since then he remained posted there. It means that the petitioner completed for more than

5 years stay in Zone-7 of District- Mahendergarh. The petitioner applied for transfer in more than 102 schools and he has been successfully allocated Govt. Primary School D/Cheema, Block- Nangal Chaudhary, District- Mahendergarh in Zone-6. Since the petitioner has been transferred on his opted school, therefore, he is not entitled to dispute his transfer under law of estoppel.

4. That the issue of transfer and posting has been considered time and again by Hon'ble Courts and entire law has been settled by catena of decisions. It is entirely upon the competent authority to decide when, where and at what point of time a public servant is to be transferred from his present posting. Transfer is not only an incident but an essential condition of service. It does not affect the conditions of service in any manner. The employee does not have any vested right to be posted at a particular place.


Whereas a kind consideration of facts above would reveal that no discrimination has been committed against the teacher. Someone has also not changed his opted schools, therefore, the presumptions of the petitioner have been found wrong, therefore, devoid of merits. The teacher holding a transferable post cannot claim any vested right to work at a particular place as the transfer order does not affect any of his legal rights and the Court cannot interfere with a transfer/posting which is made in public interest or on administrative exigency. Moreover, to dilute such type of discrimination, the present "transfer policy, 2016" has been framed which is fairly based on composite marks. Such type of discrimination would create havoc in the school administration. In this regard, the Hon'ble Supreme Court in Gujarat Electricity Board v. Atmaram Sungomal Poshani, has observed as under:-

"Transfer of a Government servant appointed to a particular cadre of transferable posts from one place to another is an incident of service. No Government servant or employee of public undertaking has legal right for being posted at any particular place. Transfer from one place to other is generally a condition of service and the employee has no choice in the matter. Transfer from one place to other is necessary in public interest and efficiency in the public administration."



Now Sh. Naresh Kumar has been transferred to Govt. Girls Primary School Akoda (Mahendergarh) tentatively and he will to take part in IInd drive of transfer necessarily. Hence, after due consideration of all facts & circumstances of the case and taking a lenient view, the petitioner has been directed to submit right option of schools and allowed to participate in 2nd phase of transfer drive to be conducted very soon in next year-2017, therefore, the petitioner is directed now to join at Govt. Primary School, D/Cheema (15091), Block- Nangal Chaudhary (Mahendergarh) immediately.

I pass order accordingly.

Whereas by way of filing CWP No. 20579 of 2016, titled as Dharmveer versus State of Haryana & others, the petitioner prayed for issuance of a writ in the nature of certiorari to get quashed impugned transfer order dated 17-09-2016 alleging therein that the impugned order of transfer qua petitioner is contrary to clause-6(i) of the State Teacher Transfer Policy, 2016. The said writ petition came for hearing before Hon'ble Court on 17-10-2016 and after hearing the counsel for the petitioner at length, the Hon'ble Court pleased to dispose of the same. The judgment is reproduced here for ready reference:

"The petitioner has impugned the order dated 17.9.2016 (Annexure P-4) whereby he has been transferred from Government Girls Primary School, Seka to Government Primary School, Taji Pur, Nangal Choudhary, District Mahendergarh.

It is stated in the petition that the petitioner has been represented against his transfer on 18.9.2016 (Annexure P-5) but the same has not evoked any response so far.

Without expressing any opinion on the merits of the case, I deem it appropriate to dispose of this petition with direction to respondent No.2 to consider and decide the representation of the petitioner dated 18.9.2016 (Annexure P-5), within a period of one month from the date of receipt of certified copy of this order.

The petition stands disposed of accordingly."

The petitioner never submitted any option that he be kept posted in Zone-7 unless and until he submits his option to continue service in Zone-7. The petitioner participated in the transfer drive, resultantly, the petitioner

has rightly been granted appropriate and due posting on basis marks as per Transfer Policy, 2016. It is his negligence that he failed to submit proper choice.

4. That the issue of transfer and posting has been considered time and again by Hon'ble Courts and entire law has been settled by catena of decisions. It is entirely upon the competent authority to decide when, where and at what point of time a public servant is to be transferred from his present posting. Transfer is not only an incident but an essential condition of service. It does not affect the conditions of service in any manner. The employee does not have any vested right to be posted at a particular place.

Whereas a kind consideration of facts above would reveal that no discrimination has been committed against the teacher. Someone has also not changed his opted schools, therefore, the presumptions of the petitioner have been found wrong, therefore, devoid of merits. The teacher holding a transferable post cannot claim any vested right to work at a particular place as the transfer order does not affect any of his legal rights and the Court cannot interfere with a transfer/posting which is made in public interest or on administrative exigency. Moreover, to dilute such type of discrimination, the present "transfer policy, 2016" has been framed which is fairly based on composite marks. Such type of discrimination would create havoc in the school administration. In this regard, the Hon'ble Supreme Court in Gujarat Electricity Board v. Atmaram Sungomal Poshani, has observed as under:-

"Transfer of a Government servant appointed to a particular cadre of transferable posts from one place to another is an incident of service. No Government servant or employee of public undertaking has legal right for being posted at any particular place. Transfer from one place to other is generally a condition of service and the employee has no choice in the matter. Transfer from one place to other is necessary in public interest and efficiency in the public administration."


After considering all the contents on file and perusing judgment (supra) of Hon'ble Court, the undersigned is of a considered view that the petitioner has no locus standi to claim posting at a particular place or block as a matter of right as he never submitted option to keep his posting in specific Zone. The petitioner failed to submit right



option as defined in clause-8 of Transfer Policy, 2016 and remained negligent, consequently, not entitled to make hue and cry against place of posting of other JBTs. It is an admitted fact that there are some merits in present representation but the same cannot be considered now as such JBTs have already joined next place of posting on transfer.

After due consideration of all facts & circumstances of the case and taking a lenient view, the petitioner has been directed to submit right option of schools and allowed to participate in 2nd phase of transfer drive to be conducted very soon in next year-2017, therefore, the petitioner is directed now to join at Govt. Primary School, Taji Pur(15103), Block- Nangal Chaudhary (Mahendergarh) immediately.

I pass order accordingly.
