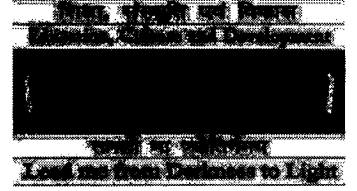



Sanction is hereby accorded under Rule 10.2 (b) read with serial No. 55 below rule 15.1 of CSR Vol.-I Part-I to the deputation on foreign service of Smt. Durgesh Nandini, Lecturer in Biology worked as Assistant Coordinator in O/o DPC, SSA, Bhiwani from 24.11.2010 to 27.09.2012 or till the end of D.P.E.P on the following terms and conditions:-

1. **Period of deputation:-** From 24.11.2010 (A.M) to 27.09.2012 (A.N) unless she recalled by the Government /parent department earlier. As per the provisions in the instructions issued by FD HR vide No. FD HR 13/5/5(86)-5 FR-I dated 17.03.1987 in Para No. 11.1, that the period of deputation shall not be extended beyond three years in any case.
2. **Dearness Allowance:** She will be entitled to dearness allowance and additional dearness allowance under the rules of the parent Government.
3. **Local Allowance:** Like Compensatory (City) allowance, house Rent Allowance to be regulated under the rules of the borrowing Government Foreign employer, However the borrowing employer may, if they so desire, apply the Haryana Government rules to such a deputationist.
4. **Joining Time/Pay and Transfer T.A:-** She will be entitled to T.A and joining time pay both on joining the post on deputation and on reversion there from to the parent Government under the rules of the Government/autonomous body to which she is deputed. The expenditure on this account will be borne by the borrowing Government/ foreign employer.
5. **Travelling Allowance:** TA for journey on duty during the period of deputation to be regulated under the rules of the Government/ autonomous body to which she proceeds on deputation.
6. **Leave Salary and Pension Contribution:** During the period of deputation on temporary transfer, she will continue to be governed by the leave and Pension Rules of the parent employee applicable to her before such transfer:-
 - i) The allocation of leave salary and pensionary charges between the borrowing/lending Government will be regulated under the rule of allocation contained in Appendix 3 to Account Code Vol.-I.
 - ii) The Autonomous Body shall pay leave salary/Pension contributions within fifteen days from the end of the month in which it is based has been drawn by the Government servant concerned after which penal rate of interest will be charges as per rule 10.12 of Civil Service Rules Vol I Part I. Rates of monthly contribution for pensionary benefits payable during active foreign service in respect of

7. **Extra Ordinary Pension/Gratuity:** This will be regulated in accordance with the Ministry of Finance (Department of Expenditure) memorandum No. F-19(23)-3v(a)/64 DATED THE 2ND August, 1965 which has been circulated vide composite Punjab Government Finance Department endorsement No. 7645-7FRI-65/18952 dated 2nd November, 1965.
8. **Leave travel Concession:** She will be entitled to leave travel concession under the rules of the Haryana Government as amended from time to time and cost thereof will be borne by the borrowing Government/Foreign employer.
9. **Leave:** To be regulated under the rules of Haryana Government.
10. **Medical Concession:** She will be entitled to those concessions under the rules of borrowing Government/foreign employer may, however, if they so desire apply the Haryana Government rules to such a deputationist.

11. **Provident Fund benefits:** During the period of deputation she will continue to subscribe to the provident fund of she is parent Government to which she may be subscribing, when she is placed on deputation in accordance with the rules of such fund.
12. **Disability Leave:** The payment of salary in respect of disability incurred in or through foreign service even though such disability manifests itself after the termination of foreign service shall be made by the borrowing Government/foreign employer.
13. **Residential Accomodation:** She will be entitled to residential accommodation according to the rules of the borrowing Government/foreign employer to which she is deputed.
Now free house or free car will be allowed nor any conveyance or conveyance allowance be provided at Government/Bodies expense unless such benefits are normally attached as a condition of service to the post of which she is deputed.
14. **Commencement of deputation:** The deputation will commence on the date on which she hands over charge of her post under the Haryana Government and end on the date on which she assumes charge of the post under that Government.
15. **Group Insurance Scheme benefit:** The officer/official will continue to subscribe to the group insurance scheme, 1985. The foreign employer shall effect recovery of the usual subscription from the pay of the officer/official and regularly deposit the same every month into Haryana Govt. Head of Account "811-Insurance-GIS, 1985." In case of delay/default, the foreign employer will deposit the arrears of subscription alongwith interest at the rate and manner prescribed in the scheme
