

ORDER

Whereas the petitioner Smt. Prem and Sh. Narender Kumar filed a CWP No. 24552 of 2015-titled as Smt. Prem & another Vs State of Haryana and others and the same was disposed of by the Hon'ble High Court vide order dated 26.11-2015. The operative part of the order is as under:-

“Accordingly, at this stage, without commenting on the merits of the case, the writ petition is disposed of with a direction to respondent no. 3 to take a decision on the representation dated 06.08.2015 (Annexure P-8) submitted by the petitioner, by passing a speaking order and after affording opportunity of personal hearing to the petitioner, preferably within four months from the date of receipt of a certified copy of this order.”

In compliance of the above order, the case of the petitioners was examined on merits by the office. The petitioner Smt. Prem in her representation dated 06.08.2015 (P-8), requested for regularization the services of her husband Late Sh. Dhanpat w.e.f. the date his juniors Smt. Sheela Devi (782) and Sh. Surender Kumar (784) services were regularized and to grant all the service benefit accrued to them on the eve of their regular services and in addition the family members of Late Sh. Dhanpat be also granted the benefit of amount of Rs. 3 Lacs as per policy of Govt. of Haryana dated 27.11.2014 for providing compassionate financial assistance.

The claim of the petitioner Smt. Prem has been considered as per instruction/policy applicable in the present case.

The brief facts of the case are that Sh. Dhanpat Late husband of Smt. Prem joined services as class-IV on part time basis vide orders dated 21.08.2000 and thereafter, he was posted in GGSSS, Devrala (Bhiwani).

A common seniority list of all part-time class-IV employees working in all Govt. Schools in District Bhiwani was prepared. The name, seniority number, qualification and place of posting of all part-



her husband Sh. Dhanpat is senior to Smt. Sheela Devi (Seniority No. 782) and Sh. Surender Kumar (Seniority No. 784) who have been regularized w.e.f. 19.08.2014. Considering her request and examining of all records available on file, I, Dr. S.S. Phulia, IAS, Director Secondary Education, is hereby order to regularize the services of Sh. Dhanpat w.e.f. the date from his junior Smt. Sheela Devi and Sh. Surender Kumar were regularized.
