1. यह कि श्री जितेन्द्र कुमार चालक ने दिनांक 02.08.2013 को लघु सचिवालय, कुरुक्षेत्र के प्रांगण में ड्यूटी करने के दौरान जिला मौलिक शिक्षा अधिकारी कुरुक्षेत्र से दुर्व्यवहार किया।
2. यह कि श्री जितेन्द्र कुमार चालक समय-2 पर अपनी ड्यूटी से अनुपस्थिति रहकर घोर अनियमितता करता है।
3. यह कि श्री जितेन्द्र कुमार चालक अपनी ड्यूटी के समय शराब सेवन करता है तथा कार्यालय आदेशों की अनुपालना न करते हुए कार्यालय को उत्तर नहीं देता।

कर्मचारी द्वारा दिनांक 19.02.2015 को चार्जशीट का जवाब दिया गया। तदोपरांत श्री आर0पी0 गरीना, सेवानिवृत्त जिला सेशन जज को निदेशालय के पत्र दिनांक 03.02.2016 द्वारा जांच अधिकारी नियुक्त किया गया। जांच अधिकारी ने अपनी जांच रिपोर्ट दिनांक 25.02.2016 को निदेशालय में दी जिसमें कर्मचारी पर लगे आरोपों को पूर्णतः प्रमाणित किया गया। आरोपित कर्मचारी को नियमानुसार पत्र दिनांक 18.04.2016 को जांच रिपोर्ट की प्रति प्रतिवेदन देने के लिए दी गई और दिनांक 04.05.2016 को निजी सुनवाई का अवसर प्रदान किया गया। कर्मचारी ने दिनांक 04.05.2016 को निजी सुनवाई के दौरान माना कि उसने अपनी सेवा के दौरान कार्य अवधि में कम-से-कम दो बार शराब पी उसने यह भी माना कि शराब पीने के बाद DIO से उलझ गया था तथा बाद में गलती का एहसास भी हो गया था। उसने विश्वास दिलाया कि भविष्य में ऐसी गलती दोबारा नहीं दोहराएगा। यदि भविष्य में ऐसी गलती करता हूँ तो विनाम उसे जो सजा देगा उसे मान्य होगी। जिस पर निर्णय लेते हुए अतिरिक्त निदेशक प्रशासन द्वारा कर्मचारी की प्रारंभिक वेतन (Initial pay) के आदेश पारित किये गये थे। इन आदेशों के विरुद्ध कर्मचारी द्वारा अपील की गई। जिसमें कर्मचारी को दिनांक 28.06.2017 को निजी सुनवाई का अवसर प्रदान किया गया। निजी सुनवाई पर कर्मचारी ने अपनी गलती मानी है।

उपरोक्त वर्णित स्थिति, कर्मचारी के उत्तर व उस द्वारा निजी सुनवाई के समय दिये गये तथ्यों तथा रिवार्ड के आधार पर यह निष्कर्ष निकलता है कि आरोपित पर लगाये गये आरोप सत्य हैं परंतु कर्मचारी का प्रारंभिक वेतन (Initial pay) करना भी कठोर सजा है। अतः मामले में सक्षम अधिकारी होने के नाते कर्मचारी को प्रारंभिक वेतन (Initial pay) की जगह दो वार्षिक वेतन वृद्धियां संचित प्रभाव से रोकने के आदेश पारित करता हूँ।
