- 3) If subsequently, it is found that any candidate has done Post Graduation or other qualifications in distance mode from deemed Universities from study centres located outside the campuses of the University, without seeking approval of UGC and the State Government, the same shall be reverted in view of Division Bench judgment of Punjab and Haryana High Court in CWP no. 1640 of 2008 decided on 06.11.2012 titled as Kartar Singh Versus Union of India and others cited in 2013(1) RSJ 224.
- 4) If the currency of penalty of stoppage of grade increments with or without cumulative effect is still in operation, the candidate(s) shall be reverted in view of Govt. instructions dated 31.5.2006.
- 5) If any discrepancy regarding not fulfilling the essential qualifications eligibility as prescribed in the Haryana State Education School Cadre (Group B) Service Rules, 2012', the said incumbent(s) shall be reverted without issuing any notice.
- 6) The promotion being based on provisional list and without prejudice to the right of the seniors to be considered if they opt for promotion as PGT provided those seniors are found eligible for the post.
- 7) In case the degree of a teacher is found not to be from a recognized University having no statutory authority/ jurisdiction in regard to award of such degree, the promotion shall be cancelled forthwith and the teachers so promoted shall be liable for strict disciplinary action.
- 8) The teachers in the provisional seniority list who are senior to the teachers whose documents have been found in order and eligible are being promoted and, posts have been reserved for them pending determination of their eligibility at a later date.

- 3) If subsequently, it is found that any candidate has done Post Graduation or other qualifications in distance mode from deemed Universities from study centres located outside the campuses of the University, without seeking approval of UGC and the State Government, the same shall be reverted in view of Division Bench judgment of Punjab and Haryana High Court in CWP no. 1640 of 2008 decided on 06.11.2012 titled as Kartar Singh Versus Union of India and others cited in 2013(1) RSJ 224.
- 4) If the currency of penalty of stoppage of grade increments with or without cumulative effect is still in operation, the candidate(s) shall be reverted in view of Govt. instructions dated 31.5.2006.
- 5) If any discrepancy regarding not fulfilling the essential qualifications eligibility as prescribed in the Haryana State Education School Cadre (Group B) Service Rules, 2012', the said incumbent(s) shall be reverted without issuing any notice.
