Whereas, Smt. Krishna Rani the then Principal BITE Sirsa now retired was charge sheeted under Rule-7 of Haryana Civil Services (P&A), Rules, 1987 vide Order No. 5/116-2008 HRG-I (1), dated 03.03.2016, wherein the following allegation was levelled against her:-


यह कि श्रीमती कृष्णा रानी द्वारा श्रीमती राजकौर, स्वीपर/चौकीदार के पद पर की गई नियुक्ति नियमानुसार पाई गई लेकिन कर्मचारी का विकासा प्रमाण पत्र नियुक्ति तिथि से 1 साल 3 महीने पहले करवाया जाना पाया गया है, जो कि विभागीय नियमानुसार गलत है।

Smt. Krishna Rani submitted her reply to the charge sheet on 02.07.2017 in which she refuted all the charges levelled against her and requested to consider her reply sympathetically in view of the justification given by her in her reply. In view of her reply, personal hearing was granted to her.

Perused the contents of the file, charge sheet under Rule 7 of Haryana Civil Services (P&A) Rules, 1987, reply thereof, submissions made at the time of personal hearing. During the course of personal hearing, she submitted that Smt. Raj Kaur was appointed on 01.03.1984 as part-time sweeper and her services was regularized on 01.03.98. She submitted medical certificate on 21.05.97 which was not accepted by the office. Thereafter, after enquiry, Civil Surgeon, Hisar vide letter dated 15.06.2016, informed that medical certificate was issued on 28.07.98 and medical certificate is genuine. Thus, the services of sweeper/chowkidar were regularized. The charge is that the medical verification was done before the orders of regularization. In this context, I observed that the medical verification was done only 3 days before the orders of regularization, which is a minor deviation and does not constitute a substantial offence.

Hence, I accept the contentions/submissions and file the chargesheet.

I order accordingly.



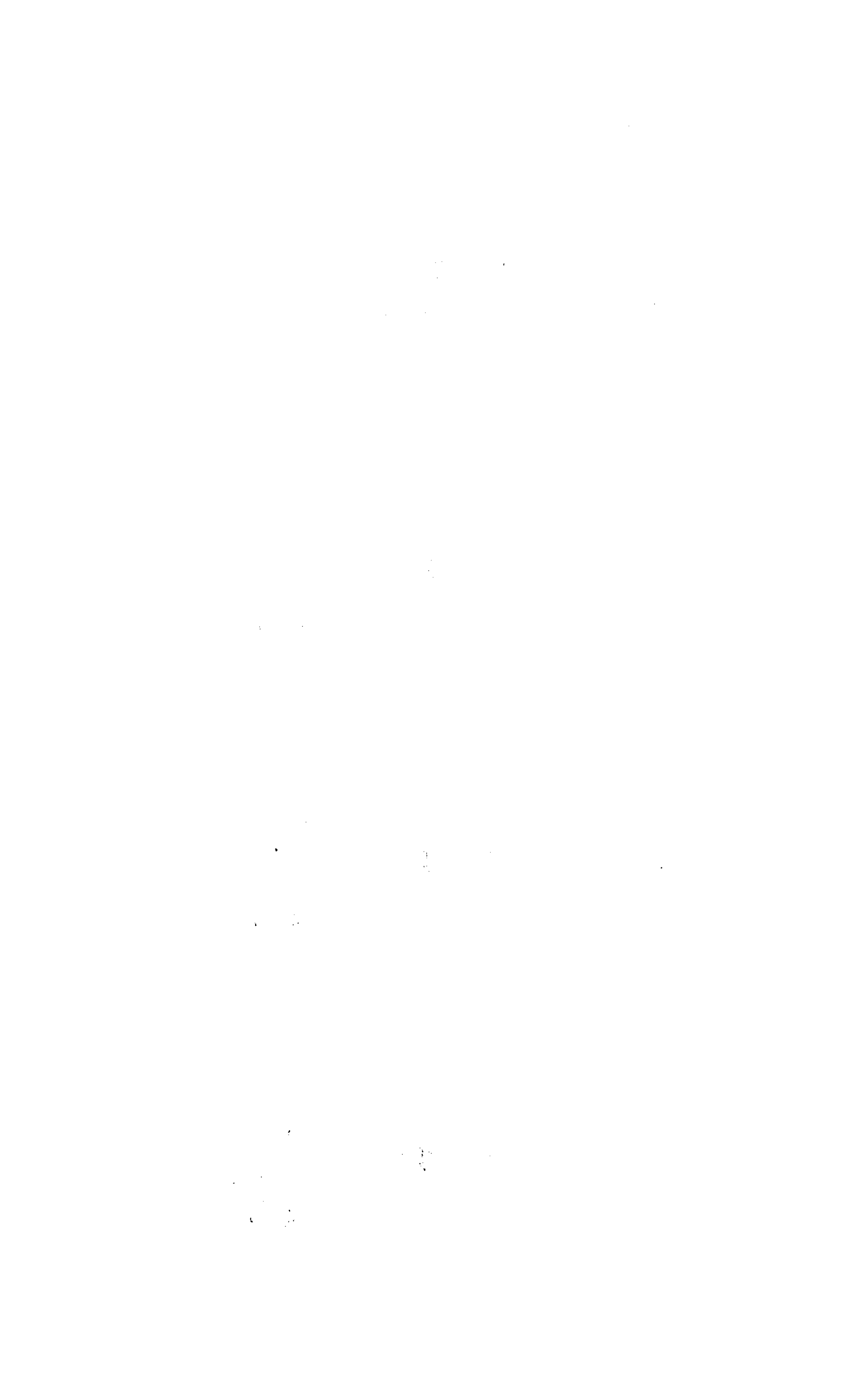

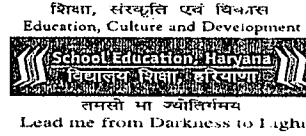

In exercise of powers conferred under Rule 29 (3) read with Rule 3 of Haryana School Education Rules-2003 Education Department, Haryana hereby permit to add new proposed classes for higher stage. However, it is made clear that such permission will not enable such school to get recognition automatically for which the applicant shall have to fulfill the required conditions.

This letter of permission is based on the undertaking given by the applicant as per details given overleaf. Any violation of the undertaking automatically nullifies the permission. This permission is further subject to 'No Objection' from the 'Competent Authority' regulating the land use of the proposed site.

मामले में कर्मचारी को अपना पक्ष रखने हेतु दिनांक 05.07.2016 को निजी सुनवाई का अवसर प्रदान किया गया। कर्मचारी द्वारा निजी सुनवाई पर लिखकर दिया गया कि निदेशालय के आदेश क्रमांक 5/25-99 एम0ई0 2 दिनांक 15.11.2000 के अनुसार उसका स्थानांतरण डाईट बीसवागील से रा0व0मा0वि0 फिरोजपुर झिरका, गुडगाव में किया गया था। जिसकी अनुपालना में उसे डाईट बीसवागील सोनीपत से 05.03.2001 को कार्यभार मुक्त किया गया था। इसके बाद 07.03.2001 को वह रा0व0मा0वि0 फिरोजपुर झिरका, गुडगाव में कार्यग्रहण करने गया तो वहां पर रिक्त पद न होने के कारण उसे कार्यग्रहण नहीं कराया गया। उसे वापिस डाईट बीसवागील सोनीपत में जाने को कहा गया। इसके उपरान्त वह बार बार डाईट बीसवागील सोनीपत के चक्कर लगाता रहा तथा पूछताछ करता रहा कि उसके स्थानांतरण आदेश प्राप्त हुये है या नहीं। उसे हर बार यही बताया जाता रहा कि निदेशालय से अभी आदेश प्राप्त नहीं हुये है अंत में परेशान होकर उसने दिनांक 09.02.2002 को लिखित में डाईट, बीसवागील, सोनीपत को दिया कि उसके स्थानांतरण आदेशों के बारे में साफ साफ बताया जाये। तब डाईट, बीसवागील सोनीपत कार्यालय ने उसे लिखकर दिया कि अभी तक आदेश प्राप्त नहीं हुये है और उसे कहा गया कि चण्डीगढ़ शिक्षा निदेशालय में जाकर अपने स्थानांतरण आदेशों का पता करें। इसके उपरान्त वह चण्डीगढ़ शिक्षा निदेशालय में आया। निदेशालय से उसने स्थानांतरण आदेश 5/25-99 एम0ई0 2 दिनांक 11.07.2001 के आदेशों की आफिस कॉपी की फोटोप्रति प्राप्त की। इन आदेशों को प्राप्त कर उसने डाईट डींग, सिरसा कार्यालय में दिनांक 14.02.2002 को कार्यग्रहण किया। इन परिस्थितियों में वह दिनांक 05.03.2001 से 13.02.2002 तक बगैर किसी कसूर के ओन रोड रहा। निजी सुनवाई उपरान्त अतिरिक्त निदेशक प्रशासन द्वारा उसकी तीन वार्षिक वेतन वृद्धियां संचित प्रभाव से रोकने और अनुपरिथत अवधि दिनांक 11.07.2001 से 13.02.2002 को अवैतनिक अवकाश के आदेश पारित किये गये। जिनके विरुद्ध अब उस द्वारा अपील की गई।

उपरोक्त वर्णित स्थिति व निजी सुनवाई पर अपीलार्थी को दिनांक 20.06.2017 को सुना गया। सुनवाई के दौरान कर्मचारी द्वारा अपने आरोप पत्र के उत्तर को दोहराया तथा अपने आप को निर्दोष बताया तथा कर्मचारी 28.02.2017 को सेवानिवृत्त हो चुका है को गध्यनजर रखते हुए उसकी तीन वेतन वृद्धियां संचित प्रभाव से बहाल करने का तथा अनुपरिथत अवधि को ड्यूटी पीरियड माना जाये। तथ्यों तथा रिकार्ड के आधार पर मैं, राक्षम

अधिकारी होने के नाते कर्मचारी की सेवानिवृत्ति को गध्यनजर कर्मचारी की सजा के आदेशों को Rendered Infructuous तथा अनुपस्थित अवधि 11.07.2001 से 12.02.2002 को leave of kind due के आदेश पारित करता हूँ।
