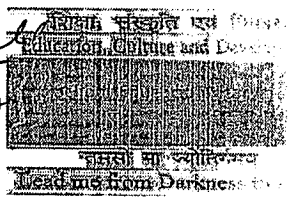

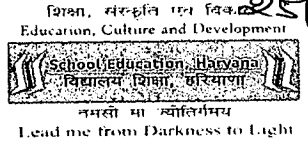

2. The school shall follow the course of study as per syllabus prescribed by the affiliated board.
