Terms and conditions:-

1. The benefit of ante-date appointment w.e.f. 06.08.2014 will be admissible to her only for notional pay fixation and seniority and actual financial benefits will be admissible to her from the date she joins duty as **PGT Sanskrit**.
2. She is appointed purely on temporary basis. This appointment is against temporary post and her confirmation against substantive post shall be considered on the basis of her seniority and record of service as and when such post is available.
3. She shall have to take an oath of allegiance to the Constitution of India.


