Whereas a charge sheet No. 5/98-2015 HRME (4)/3004 dated 13.05.2016 under rule-7 of Haryana Civil Services (Punishment & Appeal) Rules, 1987 was served upon to Sh. Dalbir Singh, Clerk, GSSS, Isharwal (Bhiwani) on the following charges:-

***That Sh. Dalbir Singh, Clerk, working in the GSSS Isharwal (Bhiwani) for the last 15 years, has been failed to report to the Principal/Higher Authority regarding absence of Sh. Sube Singh, Math Master since 12.11.2001, which shows the negligence on his part to perform his duties.***

Smt. Santosh Hooda, DEO, Hisar was appointed as Enquiry Officer to conduct the departmental enquiry vide this office order No. 5/98-2015 HRME (3) dated 23.06.2014. The enquiry officer submitted her enquiry report vide no. Steno/2016/4332 dated 08.08.2016 in which charges levelled against Sh. Dalbir Singh, Clerk, GSSS, Isharwal were proved. On receipt of the enquiry report, the office examined the report and put up before the competent authority in tabulated form.

After considering the reply to the chargesheet and enquiry report, Punishment of 3 annual increments already granted to Sh. Dalbir Singh has been withdrawn by the competent authority vide office order No. 5/98-2015 HRME (3) dated 18.11.2016 issued vide Endst. Dated 07.12.2016.

Aggrieved, from this order, Sh. Dalbir Singh filed an appeal dated 12.01.2017 against the order 5/98-2015 HRME (3) dated 18.11.2016 before the appellate authority which was considered and opportunity of personal hearing was given to the official on 19.09.2017.

After considering the office record and his submissions made during course of personal hearing, I have come to the conclusion that the explanation given by the delinquent can be considered up to certain
