**ORDER**

On recommendation of Haryana School Teachers Selection Board, Panchkula conveyed vide their Memo No. 2/1/2013-HSTSB/2014/CA/ 453 dated 30.6/03.07.2014, the Governor of Haryana is pleased to appoint Sh. Jitender Singh S/o Sh. Ransingh, VPO Devsar, District Bhiwani as Post Graduate Teacher (PGT) Sanskrit (HES-II) in the pay band of Rs. 9300-34800 + Grade Pay 4800/- plus usual allowances as admissible from time to time w.e.f. 06.08.2014 on notional basis. He is directed to join in the O/o District Education Officer, Bhiwani as mentioned below:-

**Terms and conditions:-**

1. The benefit of ante-date appointment w.e.f. 06.08.2014 will be admissible to him only for notional pay fixation and seniority and actual financial benefits will be admissible to him from the date he joins duty as **PGT Sanskrit**.
2. He is appointed purely on temporary basis. This appointment is against temporary post and his confirmation against substantive post shall be considered on the basis of his seniority and record of service as and when such post is available.
3. He shall have to take an oath of allegiance to the Constitution of India.
4. In case he is married, he shall produce a certificate, before joining duty, to the effect that he has only one living spouse. If he has more than one living spouse, he shall be eligible for appointment to the post offered only after the Government is satisfied that he has special ground for doing so, and exempt him from this condition.
5. He shall not be allowed to apply for any post outside the department for a period of at least three years.
6. He shall not claim seniority on the basis of this order. His inter-se seniority will also be decided in accordance with the relevant service

- rules and instructions of the State Government issued from time to time later on.
7. He shall be on probation for a period of two years. The period of probation can be extended for a period not exceeding one year, if considered necessary.
  8. In the matters, not specifically mentioned in this communication, he shall be governed by the Punjab Civil Services Rules as applicable to Haryana Government Employee and such orders/ instructions as may be issued by the Government from time to time.
  9. In case of reserved category candidate, the appointment is provisional and is subject to verification of the Scheduled Castes/ Scheduled tribes/Backward Class and ESM Category Certificate. If the verification reveals that the claim of belonging to SC/ST/BC and ESM, as the case may be, is false then his service will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under provisions of the Indian Penal Code for production of false certificate.
  10. Candidate is hereby directed to produce his original certificates of academic qualifications and other relevant certificate to the District Education Officer concerned along with photostat self attested copies. District Education Officer is directed to compare the photo copies with the original and thereafter original certificates and testimonials will be returned to the candidate.
  11. Medical fitness certificate issued by the concerned Civil Surgeon will be produced before the joining. District Education Officer will also give character and antecedent verification forms to him and after filling the form, the candidate would submit it to the District Education Officer concerned immediately.
  12. He shall be governed by the Haryana State Education School Cadre (Group-B) Service Rules-2012.
  13. If at any time during the course of his temporary appointment, he desires to resign, then in such eventuality, he shall be required to give one month's notice or forfeit, in lieu thereof, his one month's salary including allowances etc.
  14. No TA/DA will be admissible to the candidate for joining as PGT.

15. If he gets an appointment as PGT on the basis of his furnishing ineligible/invalid qualifications, false/forged or fraudulent information /facts which are detected later on, he would be liable for termination of service without any notice.
16. In case, he has not passed STET/HTET and B.Ed. as yet, he shall have to qualify HTET and B.Ed. by not later than 1<sup>st</sup> April, 2018, otherwise his appointment shall stand terminated automatically without giving any further notice.
17. The appointment will be subject to the final outcome of SLP No 7820 of 2013 and other connected SLPs pending for adjudication in the Hon'ble Supreme Court of India, CWP No 18693, 20344, 17656 of 2012 pending in Hon'ble Punjab and Haryana High Court.
18. The appointment will be subject to the condition of good moral character as the verification report is awaited from the District Magistrate, concerned and Superintendent of Police, concerned.
19. If he is willing to accept this offer of appointment as PGT, HES-II (School Cadre) on the above terms and conditions, he should submit his joining report as per aforesaid directions.
