

- 1) If any, disciplinary proceeding under Rule 7 or 8 of Haryana Civil Services (Punishment & Appeal) Rules, 1987 is found pending subsequently, the said incumbents(s) shall be reverted without issuing any notice.
- 2) The promotion has been given on the basis of availability of 70 percent or more records falling in the category of good or better than that and in the eventuality of finding integrity doubtful during the said period as well as remaining records, the incumbent(s) shall be reverted without issuing any notice.



- 3) If subsequently, it is found that any candidate has done Post Graduation or other qualifications in distance mode from deemed Universities from study centres located outside the campuses of the University, without seeking approval of UGC and the State Government, the same shall be reverted in view of division bench judgment of Punjab and Haryana High Court in CWP no. 1640 of 2008 decided on 06.11.2012 titled as Kartar Singh Versus Union of India and others cited in 2013(1) RSJ 224.
- 4) If the currency of penalty of stoppage of grade increments with or without cumulative effect is still in operation, the candidate(s) shall be reverted in view of Govt. instructions dated 31.5.2006.

Whereas Sh. Hemant Kumar, Clerk, O/o GSSS, Kherinaru, Karnal who was placed under suspension vide this office order dated 06.11.2007 and further he was served chargesheet under rule-7 vide this office order No. 5/89-2007 HRME (3) dated 28.01.2009 on the following charges:-

यह कि उसने श्री ऋषिपाल आर्य अध्यापक के साथ मिलकर उसके विदेश जाने की अवधि दिनांक 8.8.2000 से 6.11.2000 तक ई०ओ०एल० विदेश यात्रा करने के लिए तथा अवधि दिनांक 1.9.2004 से 31.12.04 तक 4 महीने की अवधि के लिए विदेश जाने के लिए विदेश जाने पर बिना वेतन अवकाश स्वीकृत करवाने उपरान्त बोगस हाजरियां लगवाकर उक्त अवधि का वेतन निकलवाकर श्री ऋषिपाल आर्य के साथ मिलीभगत करके वेतन का भुगतान करवाया ।

यह कि उसने श्री ऋषिपाल आर्य की अवधि दिनांक 13.3.03 से 31.7.03 तक दिनांक 27.7.04 से 31.8.04 तक की अवधि छुट्टियों की प्रविष्टि सेवापंजी में न करते हुए उक्त अध्यापक को नाजायज तौर पर लाभ पहुंचाया ।

यह कि उसने खण्ड शिक्षा अधिकारी इन्ट्री का डायरी रजिस्टर वर्ष 2000 से 2004 तक की अवधि के गुम करके उसने सरकारी रिकार्ड को खुर्द-बुर्द कर दिया ।

He replied to the chargesheet on 19.02.2009 which was not found satisfactory. Hence, the competent authority appointed Sh. V.P. Batra, IAS (Retd) as enquiry officer to conduct the regular departmental enquiry, the enquiry officer submitted his enquiry report on 25.01.2012 and concluded that charge no. 1, 2 and 4 are not succeeded and charge no. 3 is partly proved that Sh. Hemant Kumar has given the illegal benefit to Sh. Rishipal Arya, JBT Teacher by paying the salary for the period from 27.07.2004 to 31.08.2004, and he cannot be escaped from the share of responsibility, even though the amount of Rs. 18,253/- has been deposited by Sh. Rishipal Arya.

The copy of enquiry report was supplied to Sh. Hemant Kumar vide letter dated 28.02.2012. He denied the charges vide his representation dated 13.02.2012. He was given an opportunity of personal hearing on 18.07.2012 and on the basis of enquiry report and official record, before taking final decision, a show cause notice was issued to Sh. Hemant
