A forum was held under the Chairmanship of Director Secondary Education Haryana on 05.12.2017. The matter relates regarding giving scholarship to the students of both Secondary and Elementary side was discussed at length. The Budget for the year 2016 & 17 amounting to Rs. 380.2 crore was allocated to the Elementary Education Department and expenditure Rs. 294.31 crore. For this purpose total amount of Rs. 2,43,33,05,341/- received and made payment of Rs. 2,86,39,91,000/- and balance amount with Bank is Rs. 6,93,14,341/-. Further, Rs. 93.00 crore approximately was received out of which amount Rs. 2.86 crore has already been paid and amount Rs. 7.00 crore is pending for disbursement. Similarly, with regard to the Secondary Education Department against the budget allocation approximately Rs. 16693.54 lacs and out of which Rs. 103 lacs has been disbursed to the beneficiaries and approximately Rs. 32 crore was pending.

The chairperson has taken a serious view of the situation and therefore, you are hereby directed to upload the information on PFMS for the year 2017-18 and send the report immediately without further delay.

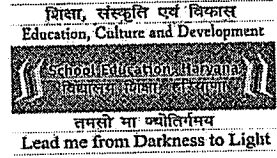

- If there is no vacancy in the destination school for any reason the incumbent transferred shall re-join his/her previous place of posting and also inform to concerned branch/computer cell at HQ. If any discrepancy is noticed in this order or there is a violation of transfer policy, It should be brought to the notice of Computer Cell/Concerned branch within three days and the order be not implemented.
- In case of mutual transfer, it is directed that before relieving/joining the officials concerned, it may be ensured that the distance between both the schools is not less than 8 km.
- The mutual transfer would be effective only when both the employees seeking mutual transfer submit a consent document to their respective Principals.
- Consent/affidavit of the official be taken that he is willing to loose his seniority in case of requested transfer orders.
- The official will be update their profile in MIS Portal when he/she join/relieve from his present working station and also supply the information to the Directorate.
- Concerned DDO is also requested to update and approved MIS data of the official at your own level.

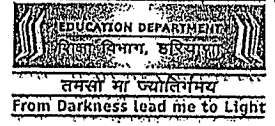

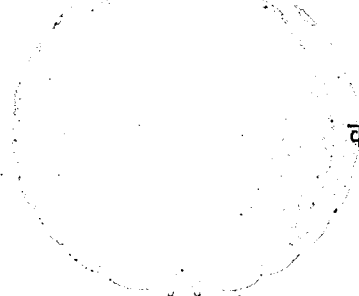

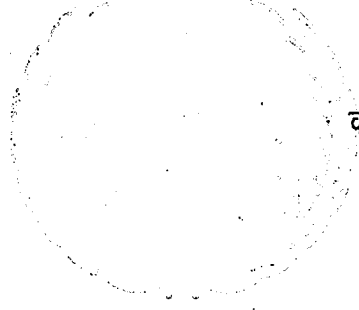
