

श्री एच.के. दहिया लिपिक, अब सेवानिवृत्त रा0उ0वि0 खेडी बुरा को मुख्यध्यापक रा0उ0वि0खेडी बुरा की रिपोर्ट के आधार पर निदेशालय के आदेश क्रमांक 5/50-1991 एच.आर.एम.ई.(4)दिनांक 21.06.1991 के तहत निलम्बित किया गया था। कर्मचारी पर फर्जी बिल बनाकर सरकारी खजाने से 17490/- रुपये का गबन करने का आरोप था। कर्मचारी पर शहर थाना चरखी दादरी में दिनांक 07.06.1991 को FIR दर्ज हुई थी। कर्मचारी को निदेशालय के आदेश क्रमांक 5/50-1991 एच.आर.एम.ई.(4) दिनांक 14.03.1997 के अन्तर्गत नियम-7 के तहत चार्जशीट जारी की गई थी। जिसमें कर्मचारी पर निम्नानुसार आरोप लगाए गए थे:-

“यह कि उसने दिनांक 03.04.1991 को एक फर्जी बिल रुपये 17490/- का बनाकर और उस पर मुख्यध्यापक के फर्जी हस्ताक्षर करके खजाने से पास करवाकर बैंक से कैश करवा लिए।”
कर्मचारी को उपरोक्त FIR में अदालत द्वारा निम्न अनुसार सजा दी गई:-

Offence Under Section	Sentenced
Section 420 IPC	Rigorous imprisonment of 1 Year alongwith fine of Rs. 200/-.
Section 468 IPC	Rigorous imprisonment of 1 Year alongwith fine of Rs. 200/-.
Section 471 IPC	Rigorous imprisonment of 1 Year 6 Months alongwith fine of Rs. 300/-.

उपरोक्त माननीय न्यायालय द्वारा दी गई सजा के सन्दर्भ में कर्मचारी द्वारा माननीय उच्च न्यायालय में याचिका दायर की। जिसको सुनने के बाद माननीय न्यायालय द्वारा दिनांक 20.09.2006 को आदेश दिए गए कि कर्मचारी जो सजा काट चुका है वह बरकरार रखी जाएगी। आगे की सजा इस शर्त पर माफ कर दी थी कि कर्मचारी 10,000/- रु0 जुर्माना राजकीय उच्च विद्यालय, खेडी बुरा (भिवानी) में जमा करवाएगा। इसी आधार पर कर्मचारी द्वारा की गई अपील को खारिज कर दिया गया था।

उपरोक्त माननीय न्यायालय द्वारा दी गई सजा के सन्दर्भ में कर्मचारी को निदेशालय के आदेश क्रमांक 5/50-1991 एच.आर.एम.ई.(4)दिनांक 23.08.2007 को सेवा से बर्खास्त करने का नोटिस दिया गया जिसके सन्दर्भ में कर्मचारी को कई बार निजी सुनवाई का अवसर प्रदान किया गया जिसमें कर्मचारी द्वारा अपने आप को निर्दोष बताया तथा विभागीय जांच करवाने का अनुरोध किया तथा सूचित किया कि उस द्वारा 17500/- रु0 व 10000/- रु0 माननीय न्यायालय के आदेशानुसार जमा करवा दिए गए। इसी कार्यवाही के चलते कर्मचारी दिनांक 31.07.2009 को निलम्बनाधीन सेवानिवृत्त हो गया। उक्त चार्जशीट पर कोई निर्णय न होने के कारण तथा कर्मचारी की सेवानिवृत्ति को मध्य नजर रखते हुए सक्षम अधिकारी द्वारा पुनः निदेशालय के



आदेश क्रमांक 5/50-1991 एच.आर.एम.ई.(4) दिनांक 31.12.2009 को पंजाब CSR Volume Part-I के नियम 2.2 बी0 के अर्न्तगत चार्जशीट जारी की गई।

कर्मचारी द्वारा चार्जशीट का उत्तर दिया गया व मामले की जांच करवाने का अनुरोध किया गया। कर्मचारी द्वारा दिया गया उत्तर सन्तोषजनक नहीं पाया गया। निदेशालय के आदेश क्रमांक 5/50-1991 एच.आर.एम.ई.(4) दिनांक 18.04.2013 के तहत श्री वी0पी0 बतरा सेवानिवृत्त आई0ए0एस को जांच अधिकारी नियुक्त किया गया। जांच अधिकारी द्वारा अपनी जांच रिपोर्ट निदेशालय में दिनांक 10.06.2014 को प्रस्तुत की गई जिसमें निष्कर्ष निकाला कि कर्मचारी को माननीय न्यायालय द्वारा पहले ही सजा पारित की जा चुकी है। अतः वे जांच करने में असमर्थ हैं। मामला एल0आर0हरियाणा को राय लेने हेतु भेजा गया। एल0आर0 हरियाणा द्वारा निम्न अनुसार राय दी गई:-

“If there is no order to withhold the pension, it has to be released and as regards passing of orders for withholding the pension, it is prerogative of competent authority and this department cannot tender any opinion qua that.”

सक्षम अधिकारी द्वारा कर्मचारी को निजी सुनवाई का मौका पुनः दिया गया जिसमें कर्मचारी कोई ठोस तथ्य प्रस्तुत नहीं कर पाया। क्योंकि सजा एवं जुर्माना माननीय न्यायालय द्वारा पहले ही कर्मचारी को किया जा चुका है। उसी आधार पर सक्षम अधिकारी द्वारा कर्मचारी की निजी सुनवाई उपरान्त निदेशालय के आदेश दिनांक 27.10.2014 के अर्न्तगत उनको 5% पेंशन में कटौती करते हुए पेंशन जारी करने के आदेश पारित किए गए तथा निलम्बन अवधि के दौरान कर्मचारी जो गुजारा भत्ता ले चुका है, उसके सिवाय कुछ भी प्रदान न करने के आदेश पारित किए गए। उक्त आदेशों के सन्दर्भ में कर्मचारी द्वारा मेरे सम्मुख अपील की गई। जिसमें कर्मचारी को दिनांक 28.04.2015 को निजी सुनवाई का अवसर प्रदान किया गया, इस दौरान कर्मचारी कुछ नए तथ्य प्रस्तुत नहीं कर सका बल्कि उन द्वारा अपना अपराध कबूल किया गया।

उपरोक्त सभी तथ्यों के मददेनजर रखते हुए अपने आदेश क्रमांक 5/50-1991 एच.आर.एम.ई.(4) दिनांक 12.05.2015 के तहत उपरोक्त दोनों आदेशों को रद्द करते हुए पुनः नए सिरे से आदेश पारित करने के निर्देश दिए। मामले का पुनः अवलोकन किया गया, पुनः अवलोकन करने उपरान्त पाया गया कि कर्मचारी को जो सजा दी गई है वह मुख्य सचिव हरियाणा सरकार की हिदायत नं0 720-5 जी0एस0-70/7100 दिनांक 02.04.1971 के अनुसार बहुत कम है। इसी आधार पर कर्मचारी के मामले में अन्तिम निर्णय लेने से पहले निदेशालय के आदेश क्रमांक 5/50-1991 एम0ई0 (4) दिनांक 04.06.2015 एवं 15.06.2015 के अर्न्तगत नोटिस जारी किया गया। उक्त दोनों नोटिसों का जवाब कर्मचारी द्वारा निदेशालय में दिनांक 26.06.2015 को प्रस्तुत किया गया। जिसमें कर्मचारी द्वारा अपने आप को निर्दोष बताते हुए निजी सुनवाई का समय मांगा। कर्मचारी को दिनांक 13.07.2015 को पुनः निजी सुनवाई का अवसर प्रदान किया गया। कर्मचारी 13.07.2015 को अद्योहस्ताक्षरकर्ता के सम्मुख पेश हुआ, लेकिन उसने अपने पक्ष में कोई नया तथ्य प्रस्तुत नहीं किया। केवल पुराने प्रतिवेदनों को ही दोहराया गया, जोकि उसके पक्ष में नहीं कहे जा सकते।



उपरोक्त सभी तथ्यों का गहनता से निरीक्षण करने उपरान्त सक्षम अधिकारी द्वारा दिनांक 27.08.2015 को कर्मचारी की पेन्शन में 10 प्रतिशत कटौती करते हुए पेन्शन जारी करने के आदेश पारित किए गए तथा निलम्बन अवधि के दौरान गुजारे भत्ते के रूप में जो वह ले चुका है उसके सिवाय और कुछ भी न दिए जाने के आदेश पारित किए गए।

उक्त आदेशों के विरुद्ध कर्मचारी द्वारा दिनांक 24.03.2017 को निजी सुनवाई का अवसर प्रदान करने का अनुरोध किया गया, जिसके सन्दर्भ में कर्मचारी को दिनांक 09.05.2017 के लिए निजी सुनवाई का अवसर प्रदान किया गया। निजी सुनवाई के दौरान कर्मचारी कोई ठोस तथ्य प्रस्तुत नहीं कर सका। लेकिन निजी सुनवाई के दौरान मुझे महसूस हुआ कि कर्मचारी की आयु लगभग 65 वर्ष हो चुकी है तथा वह कैंसर की बिमारी से पीड़ित भी है। जिसका प्रमाण कर्मचारी द्वारा मेरे सम्मुख प्रस्तुत किया गया।

अतः उपरोक्त वर्णित स्थिति के दृष्टिगत मामले में, मैं सक्षम अधिकारी होने के नाते, मामले में नरम रूख अपनाते हुए, श्री एच०के० दहिया, सेवानिवृत्त लिपिक के मामले में 10 प्रतिशत पेन्शन में कटौती को कम करते हुए 5 प्रतिशत करने की कटौती करके पेन्शन जारी करने के आदेश पारित करता हूँ।



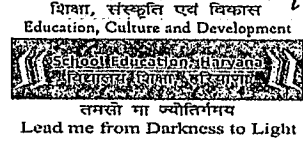

TERMS & CONDITIONS:-

However, if any information at any stage, is found contrary to the facts the recognition would be revoked forthwith.
2. The school shall follow the course of study as per syllabus prescribed by the affiliated board.
3. The school shall charge fees and funds as declared to the appropriate authority at the time of application for recognition and display the same on the notice board of the school and shall not increase the fees during the any academic session. 5. No capitation fee and other charges shall be charged from the children/parents.
6. School shall be open for admission without any discrimination based on religion, caste, race, place of birth any other whimsical.
