श्री बजरंग सिंह, सेवादार, रा0मा0वि0, सरसाना, हिसार ने माननीय उच्च न्यायालय में याचिका न0 28733 of 2017 दायर की जिसमें उसने सेवादार से लिपिक के पद पर पदोन्नत करने की मांग की गई। जिसमें माननीय उच्च न्यायालय द्वारा दिनांक 16.12.2017 को डिस्पोज करते हुए निम्न आदेश जारी किये गये जो कि निम्न प्रकार से है:-

Keeping in view the above, this Court is of the opinion that no useful purpose would be served to ask the respondents to file reply as the decision making process is still pending.

Accordingly, without commenting on the merits of the case and keeping in view the fact that the matter is still pending consideration, the present writ petition is disposed of with a direction to respondent no. 2 to take a decision on the legal notice dated 21.09.2017 (Annexure P-4) within a period of 2 months from the date of receipt of certified copy of the order. In case any adverse order is to be passed, a reasoned order be passed and conveyed to the petitioner.

उपरोक्त कर्मचारी द्वारा की गई मांग एवम माननीय उच्च न्यायालय के फैसले का अवलोकन करने उपरान्त पाया गया कि वादी श्री बजरंग सिंह, सेवादार के पद पर उद्योगिक प्रशिक्षण संस्थान हरियाणा में दिनांक 04.02.1984 को नियुक्त हुआ है और उक्त विभाग में से सरकार द्वारा ITI समाप्त कर देने के कारण उक्त विभाग द्वारा ITI में कार्यरत कर्मचारियों से विकल्प मांगे गये थे वह कर्मचारी उनके विभाग में रहना चाहते हैं या अन्य विभाग में जाना चाहते हैं। यदि उक्त कर्मचारी अन्य विभाग में जाना चाहते हैं तो उन्हें अपनी वरिष्ठता छोड़नी पड़ेगी।

उक्त कर्मचारी द्वारा अन्य विभाग में जाने का विकल्प देने के कारण उपरोक्त विभाग द्वारा वादी का नाम इस विभाग में स्थानांतरण आधार पर नियुक्त करने हेतु भेजा गया। जिसके बाद इस विभाग द्वारा कर्मचारी को नई नियुक्ति प्रदान करते हुए दिनांक 01.07.2009 को रा0मा0वि0, सरसाना, हिसार में सेवादार के पद पर नियुक्ति प्रदान कर दी गई। जिसके कारण कर्मचारी की वरिष्ठता वर्ष 2009 से ही इस विभाग द्वारा मानी गई है। वादी द्वारा अपने से जूनियर जिन कर्मचारियों का उदाहरण दिया गया है वह उक्त कर्मचारी से जूनियर नहीं है क्योंकि इस विभाग द्वारा जो चतुर्थ श्रेणी कर्मचारी दिनांक 17.06.2006 तक इस विभाग में नियमित नियुक्त हुए थे, केवल उन्हीं की पदोन्नति सूची दिनांक 20.09.2017 को जारी की गई है। उक्त कर्मचारी की नियमित नियुक्ति इस विभाग में वर्ष 2009 के बाद की है, इसलिए वादी श्री बजरंग सिंह, सेवादार इस विभाग के क्षेत्रिय कार्यालय सेवानियम 1983, संशोधित नियम दिनांक 08.11.2013 के अनुसार पदोन्नति का पात्र नहीं बनता।

इसलिए उपरोक्त अंकित स्थिति के दृष्टिगत मैं मामले में सक्षम अधिकारी होने के नाते श्री बजरंग सिंह, सेवादार, रा0मा0वि0, सरसाना, हिसार द्वारा किये गये क्लेम को अस्वीकार करने के आदेश पारित करता हूँ।
