CAUSE NOTICE

Order No. 5/91-2015 HRME (3)

Dated, Panchkula the, 19.01.2018

Ld. Judicial Magistrate, First Class, Ambala vide order dated 01.09.2015 has inflicted the following punishment upon Sh. Amarjit Singh, Dy. Supdt (Retd) in the criminal complaint no. 129/1/2008 titled as Hari Singh Versus Sukhwinder Singh and others:-

1	U/S 420 OF IPC	Two Years Simple Imprisonment and Rs 500/- each as fine
2	U/S 467 of IPC	Two Years Simple Imprisonment and Rs 500/- each as fine
3	U/S 468 of IPC	Two Years Simple Imprisonment and Rs 500/- each as fine
4	U/S 471 of IPC	Two Years Simple Imprisonment and Rs 500/- each as fine
5	U/S 120 B of IPC	Six Months Simple imprisonment
All the sentences shall run concurrently		

Therefore, said Sh. Amarjit Singh filed Criminal Appeal No. 333 of 2015 against the judgement of conviction and order of sentence dated 31.08.2015 passed by the Court of Ms. Rekha Ld. JMJC, in the court of Ld. Additional Session Judge, Ambala, who vide its order dated 17.09.2015 suspended the said sentence during the pendency of the appeal. This clearly implies that the conviction remained intact and was not stayed by the Appellate Court.

The said incumbent got superannuated at the age of 58 years on 31.01.2016. In view of conviction in a serious crime, prima facie, it was imperative to impose a penalty of dismissal, in accordance with the offences pertaining to the moral turpitude, as provided in proviso (a) to Article 311 (2) of the Constitution of India and as per instructions issued by Punjab Government Circular Letter No. 4819-G II-57/11919, dated 08.07.1957 from the Chief Secretary to Government, Punjab, addressed to all the Heads of Departments, which was not done till the date of retirement on 31.01.2016 and the said incumbent continued to get pension. As a consequence of the same, the competent authority issued show cause notice to Sh. Amarjeet Singh vide office letter No. 5/91-2015 HRME(3) dated 22.07.2016 proposing penalty of withholding or withdraw a pension or any part of it.

The Retd official replied to the abovesaid notice on 11.08.2016 in details interalia mentioning that this notice is not sustainable in present form.

Hence, in view of aforesaid orders dated 06.12.2017 passed by Hon'ble High Court, the show cause notice dated 22.07.2016 served upon to Sh. Amarjeet Singh Deputy Superintendent (Retd) is hereby withdrawn.

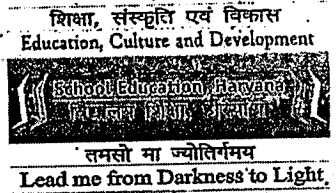

It is stated that the petitioners have filed present Civil Writ petitions praying therein for quashing the impugned action of the respondents whereby despite the order dated passed by Hon'ble High Court in CWP 9347 of 2016 – Jagat Singh and others V/s State of Haryana and other, the benefit of Selection Grade of Rs 7500 – 12,000 has been granted to the petitioners with effect from 01.08.2000 instead of 01.01.1996 for the post of lecturers as per Government of Haryana letter dated 12.12.2000 vide which Head Master of Government High Schools and the 20% cadre posts of Lectures have been granted the pay scale of Rs 7500-12000 w.e.f. 01.01.1996 instead of 01.08.2000 in compliance with direction given in CWP NO 8082 of 2001 titled as RK Verma and others V/s State of Haryana and another, allowed on 01.12.2010, LPA No 951 of 2011 titled as State of Haryana V/s R K verma others, dismissed on 31.10.2012, SLP of the State of Haryana dismissed on 01.11.2013 and even the Review Petitioner has dismissed by the Hon'ble Apex Court on 02.12.2014 and the issue is already settled that the pay anomaly has to be removed from the date of inception. It has further been prayed that benefit of selection grade to the petitioner may be granted from 01.01.1996 instead of 01.08.2000 with all consequential benefits.

In this regard, petitioner in various writ petition, have raised the similar issue, were granted requisite relief in the light of Hon'ble High Court order




dated 20.02.2017 passed in CWP NO 9347 of 2016 – Jagat Singh V/s State of Haryana vide this office order dated 04.12.2017.

The amount of budget for payment of pension for the period 01/04/2017 to 31/03/2018 along with arrear of pension and DA increased by the Govt. From time to time is allocated as tabulated above and pension may be drawn strictly according to PPOs issued by this Directorate subject to the following conditions:-

1. The amount shall be chargeable/debitable Major Head **"2202 General Education-02-Secondary Education-110-Assistance to Non-Govt. Secondary Schools [96] Introduction of pension Scheme for Non-Govt. Aided Secondary Schools- 09) Grant-In-Aid-General(Non- Recurring)as figuring in the printed Budget for the year 2017-18.**
2. The required amount of pension/family pension may be drawn only as per actual pension bills prepared by the concerned DEO's on the basis of actual payable pension/family pensions. The required amount may be drawn from the Treasury only after adjusting the undisbursed amount of budget lying unspent in the offices of concerned DEOs. Excess funds may not be drawn from treasury.
3. The rule of life certificate/remarriage/reemployment and attainment of majority must be followed strictly so as to avoid any over payment to the

pensioner/F.P.

4. It may be ensured by the concerned DEOs. That recoverable amount as mentioned in PPOs on account of CPF and other recovery has been recovered from the concerned retiree. Recoverable amount may be deducted from the pension bills before making the payment of pension/family pension to the retirees or dependents of deceased employees of aided schools.
5. Entitlement of pension/family pension may also be ensured by the concerned DEOs before making the payment.
6. All the cases of death/re-marriage/re-employment also be informed timely to the department.
7. DA on Pension is admissible as per the rates sanctioned by the Govt. from time to time.
8. Utilization certificate of released pension/family pension and copy of the pension bills duly verified by Section Officer and counter signed by the DEOs alongwith softcopy (CD) of the pension bills may be sent to the Directorate within 15 days positively.
9. Pension may be released after obtaining the Live Certificates of the pensioners/family pensioners as per rules. It may also be ensured that recovery, if any, on account of CPF recovery or any other recovery shown in the PPO has been made from the pensioners/family pensioners.
10. Utilization certificate of earlier released budget for pension/family pension may be obtained from the concerned school managements and the same should be sent to the Directorate up to 31.03.2018.

It may please be ensured that these funds are utilized for the purpose for which it has been sanctioned keeping in view the instructions issued vide Commissioner-Cum-Director General School Education Haryana, Chandigarh letter No. 10/1-98 P -II dated 10-1-2002 and no financial irregularities be committed in transactions.

The concurrence of the Finance Department has been conveyed vide Finance Department vide U.O. No. 5/7/2005-1(B&C) dated 09.05.2005 and U.O. No. 5/6/2005-5 (B&C) dated 11.06.2010 and administrative approval has also been issued vide letter No. 7/1-2017 Pension-II (2) dated 12.04.2017.
