Whereas, Smt. Asha Rani, PGT Economics, Govt. Sr. Sec. School, Devidass Pura (Kurukshetra) approached the Hon'ble High Court by way of CWP No. 9337 of 2017 titled as Asha Rani V/s State of Haryana and others claiming therein the benefit of step up the pay of the petitioner at par with her junior i.e. respondent No. 5 Smt. Kusum Gupta. The Hon'ble High Court disposed of the writ petition on the basis of statement of State Counsel. The operative part of the order dated 18.01.2018 are reproduced as under:-

*“\*\*\*In response, learned State counsel submits that the claim as also the grievance of the petitioner, as set out in the petition, shall be considered and dealt with within a period of three months from today and appropriate orders, in accordance with law, shall be passed.*

*That being so, the petition is disposed of in the above terms. Needless to assert that in the event the claim of the petitioner is declined, the respondent authorities shall pass a comprehensive order assigning reasons in support thereof.”*

*Pm*  
Accordingly, the case of the petitioner is examined. The petitioner, Smt. Asha Rani was appointed as Math Mistress on 03.09.1984, which is a Master Cadre post and subsequently regularized on 01.11.1986. She was promoted as PGT Economics in 2004. Her junior counterpart respondent No. 5 Smt. Kusum Gupta was appointed as Hindi Teacher on 01.11.1986, which is a Classical & Vernacular Cadre post and promoted as PGT Hindi in 2006.

The petitioner was working as Math Mistress (Master Cadre post) whereas her junior counterpart was working as Hindi Teacher (Classical & Vernacular Cadre post). As such, they do not belong to the same cadre. Further, the petitioner Smt. Asha Rani has already got three financial upgradations on

account of ACP, whereas, her junior counterpart Smt. Kusum Gupta got 3<sup>rd</sup> ACP in March 2014.

As per rule i.e. Note-7 of Rule-18 of ACP Rule-7 (a) both the junior and the senior Govt. servants should belong to the same cadre and the same ACP pay band in which they have been moved should be same and in the same cadre."

In this case, they are neither in the same cadre nor in the same pay band. As such, the petitioner is not entitled to step up her pay.


