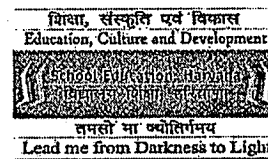

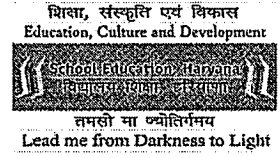

“यह कि आप द्वारा श्री सज्जन कुमार, संस्कृत प्राध्यापक की सेवापंजी वेतन निर्धारण हेतु जिला शिक्षा अधिकारी, सोनीपत के कार्यालय में ले जाते समय गुम कर दी गई। वर्ष 2009 में सेवापंजी गुम हो गई जिसकी जांच खण्ड शिक्षा अधिकारी व प्राचार्य, रा0क0व0मा0वि0, खरखौदा द्वारा की गई तथा जांच के दौरान पाया गया कि कर्मचारी की सेवापंजी विद्यालय स्तर पर गुम की गई है। विद्यालय के लिपिक पर समस्त स्टाफ सदस्यों एंव विद्यालय के अन्य रिकार्ड की जिम्मेदारी होती है। अतः प्राध्यापक की सेवापंजी गुम करना उसकी लापरवाही को दर्शाता है और यह कर्मचारी द्वारा जांच के दौरान अपने शपथ पत्र में भी स्वीकार किया है।”

कर्मचारी द्वारा दिनांक 15.05.2018 को चार्जशीट का उत्तर देते हुए उसके विरुद्ध जारी आरोप पत्र को फाईल करने व निजी सुनवाई का अवसर मांगा गया। इसके उपरांत कर्मचारी को दिनांक 25.07.2018 को निजी सुनवाई का अवसर प्रदान किया गया। सुनवाई पर कर्मचारी द्वारा अपना लिखित प्रार्थना पत्र दिया गया और उस द्वारा माना गया कि उसके द्वारा गलती की गई है और सेवानिवृत्त कर्मचारी की ड्रुप्लीकेट सेवापंजी तैयार कर दी गई है और इनका कोई वित्तीय मामला भी लिखित नहीं है बारे अवगत कराया और उसकी 30 वर्ष की सेवा में उसके उपर कोई आरोप नहीं लगा।

उपरोक्त वर्णित स्थिति, कर्मचारी द्वारा दिये गये प्रार्थना पत्र और निजी सुनवाई पर उसे सुनने उपरांत, मैं, सक्षम अधिकारी होने के नाते कर्मचारी को भविष्य में सचेत रहने की चेतावनी देता हूँ कि और इन आदेशों की एक कॉपी उसकी निजी मिसल में संलग्न की जाये।

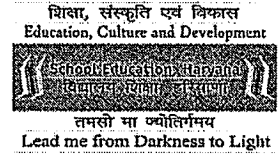

Whereas, the petitioner namely Smt. Namrata Kumari, PGT (Sociology) approached to Hon'ble Punjab & Haryana High Court at Chandigarh by way of filing CWP No. 8584 of 2018 titled as Namrata Kumari versus State of Haryana & others praying therein to quashing the transfer Order No. 13/163-2017 PGT-II (5) dated 02-02-2018 vide which she was been adjusted from Govt. Girls Senior Secondary School, Rewari (2541) to Govt. Senior Secondary School Bawal (2516), District Rewari. After considering the allegations in the writ petition, the Hon'ble High Court vide its order dated 26-04-2018 has observed and issued directions to respondents as under:

"This is a petition against a transfer order. The petitioner after having served in one school for nearly 08 years has been transferred to school which is only 20 kilometers away from the present place of posting. No prejudice has been shown to have caused to the petitioner nor any malafides are alleged against any authority. Some inconvenience is always involved in postings and transfers.

Needless to say that if the petitioner has any genuine grievance as contained in her petition, it is for the authorities in the first instance to examine and decide that. The petitioner would be heard on her grievance and the decision will be taken. The petitioner will make a composite representation before the competent authority by Monday i.e. 30.04.2018 and the authorities will decide the representation within one week thereafter."

Thereafter, the petitioner i.e. Smt. Namrata Kumari made its composite representation dated 29-04-2018 in this Directorate with three prayers therein i.e. to withdraw the adjustment order dated 02-02-2018, transfer the petitioner back to Govt. Girls Senior Secondary School Rewari (2541) and action against Smt. Sunita Yadav who is beneficiary under clause-16 of Revised Teacher's Transfer Policy, 2016 uploaded on Departmental Website on 29-06-2016. Considering the representation, the petitioner was granted opportunity of personal hearing with liberty to submit all her grievances with documentary evidences on 13-08-2018.

After due consideration of factual position, it has come into notice that the petitioner joined services on post of PGT (Sociology) on 23-12-2008 at Govt. Senior Secondary School Garhi Bolni (2474) District

Rewari. Thereafter, she got herself adjusted under garb of deputation vide this Directorate Order No. 2/30-2009 HRL (2) dated 28-08-2009 at Govt. Senior School School Rewari. She also got extended this deputation till 31-12-2013. She was repatriated on 01-01-2014 to her parental school i.e. GSSS Garhi Bolni but she remained posted there till 31-01-2014 i.e. for one month only. She again got herself transferred from GSSS Garhi Bolni to GGSSS Rewari and joined services there as PGT (Sociology) on 31-01-2014.

Thereafter, on 29-06-2016, this Directorate issued rationalization policy for the post of PGTs on the basis of enrollment of students and workload. It has been found that GGSSS Rewari has only workload of one PGT (Sociology). The petitioner, being regular PGT was informed about these facts by the Principal vide School Order No. 450/2016 dated 01-07-2016. She rushed immediately to District Courts at Rewari by way of filing Civil Suit No. 75 of 2016- Namrata Kumari versus State of Haryana & others including Smt. Mamta Yadav and got a status quo vide Hon'ble Civil Court order dated 14-07-2016 against rationalization and adjustment till further order. Thereafter, Smt. Mamta Yadav was transferred from GGSSS Rewari to GSSS Nangal Teju (Rewari) and the petitioner was kept intact in her school even after rationalization of posts. The petitioner did not disclose this fact to Hon'ble Civil Court at Rewari and kept the status quo continued without having any grievance.

It has also been noticed that the petitioner remained posted at Rewari either at GSSS Rewari or GGSSS Rewari from September 2009 to till this order of transfer cum adjustment i.e. order dated 02-02-2018 which accounts for approximately 8 years 5 months but she has shown herself posted at Rewari on MIS Portal w.e.f. 31-01-2014, having only 4 years stay at Rewari and got it approved from Principal. In this way, she is found liable for disciplinary action under Clause 16 of Revised Teachers' Transfer Policy 2016 dated 29-06-2016.

It is also relevant to consider that the number of posts to be sanctioned in a school depends upon the number of students or number of periods to be attended by a PGT or TGT as the case may be. Sanction of new post or rationalization of existing posts is a continuous process. The petitioner is an employee of State Cadre Service. She is liable to serve at any school within the State of Haryana under provisions of Rule-12 of the Haryana State Education School Cadre (Group B) Service Rules, 2012 which says as under:

"12. Liability to Serve:

- (1) *A member of the Service shall be liable to serve at any place, whether within or outside the State of Haryana on being ordered so to do by the appointing authority.*
- (2) *A member of Service appointed by the direct recruitment shall be liable to serve for a continuous period of five years in the rural area from the date of appointment.*
- (3) *A member of Service appointed by promotion or by transfer shall be liable to serve for a continuous period of three years in the rural area from the date of such appointment, if not already served for a period of fifteen years in the rural area.*
- (4) *A member of the Service may also be deputed to serve under:-*
- (i) a company, an association or a body of individuals whether incorporated or not, which is wholly or substantially owned or controlled by the State Government, a municipal corporation or a local authority or university within the State of Haryana;*
 - (ii) the Central Government or a company, an association or a body of individuals, whether incorporated or not, which is wholly or substantially owned or controlled by the Central Government; or*
 - (i) any other State Government, an international organization, an autonomous body not controlled by the Government, or a private body:*


Provided that no member of the Service shall be deputed to serve the Central or any other State Government or any organization or body referred to clause (ii) or clause (iii) except with his consent."

Since the petitioner neither served for statutory period of five years in rural area nor was transferred or adjusted in a company, an association or a body of individuals or the Central Government or a company, an association or a body of individuals which binds the respondents to seek her consent before issuing such order, therefore,

it is sufficient to establish that the petitioner approached Hon'ble Court with mala fide intention to remain posted at GGSSS Rewari.

Considering all factual position of petitioner's service record, it has been found that the petitioner is not only misleading the Hon'ble Courts but bringing ill names to this Directorate also. She is nowhere an aggrieved PGT. Moreover, it has been found that she wants to remain posted at City - Rewari only. She has been found guilty of uploading wrong facts of her service stay on MIS portal which made her liable for disciplinary action under Clause 16 of Teachers' Transfer Policy, 2016 and the same be initiated against her positively. After perusing all the factual position in light of Teachers' Transfer Policy as well as statutory Service Rules i.e. the Haryana State Education School Cadre (Group B) Service Rules, 2012, I found her representation dated 29-04-2018, devoid on merits. Accordingly, the relief claimed therein also deserves to be declined.

I, order accordingly.

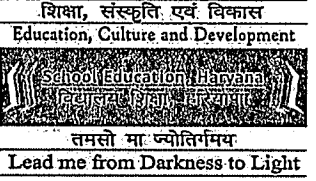

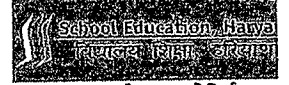

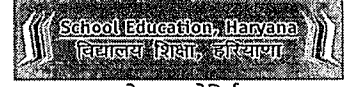
