



It is stated that Hon'ble Court of Shri Sukhdev Singh, Judicial Magistrate, 1st class has already acquitted Shri Parkash Chand from the charge leveled in the FIR 0526 dated 21.08.2015 vide order dated 01.03.2017 passed in Criminal Case No. 203 of 2015.

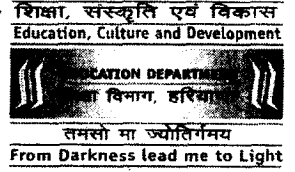

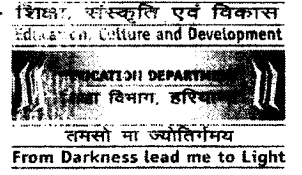
