1. That Sh. Zile Singh purchased gas chullahs, lighter, pipe, regulator and burner @ Rs. 2500/- plus VAT charges from Ambala Central Co-op. Consumer Store, Chandigarh whereas as per Director supplies and Disposal Department Letter No. 28683 dated 30.01.2008, it was not an approved source for the said items.
2. That in the open market the price of the said items is about Rs. 884/- but Sh. Zile Singh has purchased the same @ Rs 2,500/- plus VAT charges in violation of the direction of the department issued vide letter No. 1/96-2000-MDM (1) dated 01.02.2007 and rules of the Finance Department and consequently, caused a loss of Rs. 9,34,356/- to the Government, Furthermore, the said gas chullahs were also not ISI marked.

In response to the above chargesheet, he has submitted his reply to the Chargesheet. In light of the charge-sheet and reply, the matter was enquired by Sh. V.P Batra, IAS Retired. After receiving the enquiry report, the order for dismissal has been issued to Sh. Zile Singh. Against this order, Sh. Zile Singh had filed CWP No. 16512 of 2014 and Hon'ble Punjab and Haryana High Court has set aside the order of dismissal on 4.2.2016 and decided the case in terms of the decision passed on 2.8.2013 in CWP No. 6315 of 2012 filed by Smt. Suman Nain.

Accordingly, the dismissal order of Sh. Zile Singh has been withdrawn on 9.8.2017 but the suspension period from 16.1.2008 to 5.3.2008 could not be finalized at that time.

Therefore, it has been decided that the suspension period from 16.1.2008 to 5.3.2008 of Sh. Zile Singh, Retd. DEO Sonipat is treated as duty period for all purposes.
