In exercise of powers conferred under Rule 29 (3) read with Rule 3 of Haryana School Education Rules-2003 Education Department, Haryana hereby permit to add new proposed classes for higher stage. However, it is made clear that such permission will not enable such school to get recognition automatically for which the applicant shall have to fulfill the required conditions.

This letter of permission is based on the undertaking given by the applicant as per details given overleaf. Any violation of the undertaking automatically nullifies the permission. This permission is further subject to 'No Objection' from the 'Competent Authority' regulating the land use of the proposed site.

The permission to add new proposed classes for higher stage is only 'In-principle' approval of the Education Department to allow applicant to initiate steps and provide infrastructure to the new proposed classes of higher stage.

Students should not be admitted only on this permission without getting recognition. The recognition will be granted R.T.E. Rules-12 Appendix-II by the Department on fulfillment of prescribed norms as provided in Haryana School Education Rules-2003, in the interest of safety, health and welfare of students and other requirements.

* The managing committee shall abide by the provisions of Haryana School Education Rules 2003 (amended) & R.T.E. Rules 2011 and amendments if any thereafter. The Managing shall be liable for disciplinary action in case of violation of any provisions of the rules.

After receipt of the notice in CWP No. 28025 of 2017 titled as Krishan Kumar and others Vs. State of Haryana and others, it has come to the notice of the Department that Sh. Ramesh Kumar, who is at present working on the post of PGT Physical Education in Govt. Sr. Sec. School, Haluwas, Bhiwani (401) was wrongly promoted to the post of PGT Physical Education vide this office order No. 15/13-2017 PGT II (3) dated 24.04.2017.

The details of the case are as under:-

Those TGTs/DPEs who acquired the requisite qualification from Deemed Universities i.e. Institute of Advance Studies in Education, Sardarshahr, Rajasthan, Vinayaka Mission University, Salem (Tamilnadu), Janardan Rai Nagar Rajasthan Vidyapeeth University, Udaipur, could not be considered eligible for promotion by the Department on the basis of decision taken by Division Bench of Hon'ble High Court in CWP No. 1640 of 2008 decided on 06.11.2012 titled as Kartar Singh V/s Union of India and others cited in 2013 (1) RSJ 224. In CWP No. 7626 of 2015-Gurmail Kaur and others V/s State of Haryana and others and also in view of clarification made by UGC (University Grant Commission) vide its letter dated 12.07.2013 that abovesaid Deemed Universities have not been granted any permission to run Open Study Centre in the Haryana State. Moreover, State of Haryana has also not granted any such permission to the said universities.


Sh. Ramesh Kumar, PGT Physical Education, Govt. Sr. Sec. School, Haluwas, Bhiwani (401) acquired his post graduation from Institute of Advance Studies in Education, Sardarshahr, Rajasthan in the year of 2010,

this university falls in the category of Deemed University. So, it is clear that you are not eligible for promotion on the basis of said qualification. However, office erroneously promoted Sh. Ramesh Kumar on the post of PGT Physical Education.

Keeping in view, the above facts, Sh. Ramesh Kumar who is presently working on the post of PGT Physical Education in Govt. Sr. Sec. School, Haluwas, Bhiwani is ordered to be reverted to his previous post of TGT. However, before doing so he is served upon a Notice of Reversion. If he does not submit his reply within 15 days from the date of this notice, Department will decide the matter ex-parte.
