

Re-allotment of funds under the Pension Scheme to the Govt. aided Schools (Secondary) for the year 2017-18 (Non-Recurring).

The following funds for the payment of Pension to the pensioner/family pensioner of Govt. Aided Schools of your District for the period 01/03/2017 to 28/02/2018 as per your demand for utilization during the current financial year 2017-18 are hereby placed at your disposal for disbursement as per PPOs already issued:-

Rs. 30,00,000/- (Rs. Thirty Lac only)

The amount of budget for payment of pension for the period 01/04/2017 to 31/03/2018 along with arrear of pension and DA increased by the Govt. From time to time is allocated as tabulated above and pension may be drawn strictly according to PPOs issued by this Directorate; subject to the following conditions:-

1. The amount shall be chargeable/debitable Major Head "2202 General Education-02-Secondary Education-110-Assistance, to Non-Govt. Secondary Schools [96] Introduction of pension Scheme for Non-Govt. Aided Secondary Schools- 09) Grant-In-Aid-General(Non- Recurring)as figuring in the printed Budget for the year 2017-18.
2. The required amount of pension/family pension may be drawn only as per actual pension bills prepared by the concerned DEO's on the basis of actual payable pension/family pensions. The required amount may be drawn from the Treasury only after adjusting the undisbursed amount of budget lying unspent in the offices of concerned DEOs. Excess funds may not be drawn from treasury.
3. The rule of life certificate/remarriage/reemployment and attainment of majority must be followed strictly so as to avoid any over payment to the pensioner/F.P.

4. It may be ensured by the concerned DEOs. That recoverable amount as mentioned in PPOs on account of CPF and other recovery has been recovered from the concerned retiree. Recoverable amount may be deducted from the pension bills before making the payment of pension/family pension to the retirees or dependents of deceased employees of aided schools.
5. Entitlement of pension/family pension may also be ensured by the concerned DEOs before making the payment.
6. All the cases of death/re-marriage/re-employment also be informed timely to the department.
7. DA on Pension is admissible as per the rates sanctioned by the Govt. from time to time.
8. Utilization certificate of released pension/family pension and copy of the pension bills duly verified by Section Officer and counter signed by the DEOs alongwith softcopy (CD) of the pension bills may be sent to the Directorate within 15 days positively.
9. Pension may be released after obtaining the Live Certificates of the pensioners/family pensioners as per rules. It may also be ensured that recovery, if any, on account of CPF recovery or any other recovery shown in the PPO has been made from the pensioners/family pensioners.
10. Utilization certificate of earlier released budget for pension/family pension may be obtained from the concerned school managements and the same should be sent to the Directorate up to 31.03.2018.

It may please be ensured that these funds are utilized for the purpose for which it has been sanctioned keeping in view the instructions issued vide Commissioner-Cum-Director General School Education Haryana, Chandigarh letter No. 10/1-98 P -II dated 10-1-2002 and no financial irregularities be committed in transactions.

The concurrence of the Finance Department has been conveyed vide Finance Department vide U.O. No. 5/7/2005-1(B&C) dated 09.05.2005 and U.O. No. 5/6/2005-5 (B&C) dated 11.06.2010 and administrative approval has also been issued vide letter No. 7/1-2017 Pension-II (2) dated 12.04.2017.

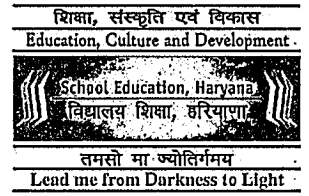

8. That the candidates would remain on probation for a period of one year, which can be extended if their service is not found satisfactory as per the rules.
9. That after joining at the school allotted herein, the candidate shall proceed on a School Leadership Training Programme to be imparted through *Teacher Education Institutions* controlled by the SCERT, Haryana. The detail programme in this respect would be communicated by the SCERT, Haryana.
