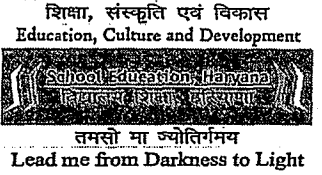

5. Head of the Institution may obtain the consent/affidavit of the official that he/she is willing to lose his/her seniority in case of requested transfer orders.



Whereas, the petitioners have filed the CWP No. 14943 of 2018 titled as Umesh Kumar and others Vs State of Haryana and others, praying therein that to direct the respondents to grant the petitioners who are working as a sweepers on the minimum of pay scale (at the lowest level, in the regular pay scale) as extended to regular employees or atleast revise the wages of petitioners from the due date as per DC rates and allow them the difference of wages as has been done by the State of Haryana. The above mentioned CWP came up for hearing on 1-6-2018 and the Hon'ble High Court was pleased to disposed off the same. The operative part of order is as under:-

“The writ petition is disposed off with a direction to respondent No. 2 to objectively consider the legal notice dated 26-2-2018 (Annexure P-11), in light of the law laid down by this Court in CWP No. 1133 of 2010 Ram Harsh and others Vs State of Haryana and others decided on 19-5-2011 by passing a speaking order thereupon, within a period of 8 weeks from the date of receipt of a certified copy of this order”.

In compliance of the above said order, the case record and legal notice was called upon by DEEO, Ambala and after examining the claim of the petitioners and whole record of the case of the petitioners, it was found that the petitioners were engaged in the year 2007 by the department on the part-time basis. They are being paid wages as per DC rate considering there engagement for one and half hour only and presently they are getting consolidated major emoluments of Rs. 2,361/- which the petitioners are deserve as per DC rates and their time of work.

Therefore, the claim of petitioners is not maintainable and against the norms. Hence the claim of the petitioners is hereby rejected.

I, order accordingly.

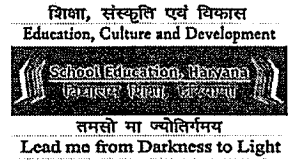

Whereas, Shri Rajesh Kumar [033585] the then Principal, Government Senior Secondary School, Buroli [2521] (Rewari) now posted at Government Senior Secondary School, Nahar [2584] , Mahendergarh was charge-sheeted under rule 7 of the Haryana Civil Services (P&A) Rules 2016 vide order dated 19.12.2017/04.01.2018 and the following allegation was levelled against him:-

"That grant of Rs 10,88,900/- was allotted for repair and construction of toilets under 'National Bank for Agriculture and Rural Development' scheme for the year 2014-15. The construction work was inspected by the Engineering Cell office of Director Secondary Education, Haryana, Panchkula wherein it was assessed that an amount of Rs 7,31,000/- was spent on the said construction work. Thus, an amount of Rs 3,07,900/- were shown to be overspent on the construction work by him i.e. Shri Rajesh Kumar. His explanation was called vide letter dated 05.04.2017 and his reply dated 14.09.2016 was not found to be satisfactory as the same was not also signed by any technical member. So,, the same could not be considered as an authenticated evidence. Thus, he i.e. Shri Rajesh Kumar caused a total sum of Rs 3,07,900/- to the State Exchequer".

Shri Rajesh Kumar, Principal furnished his reply to the charge sheet on 05.02.2018 and denied all the charges levelled against him. He stated in his reply that he was not in his office on the day of inspection made by Shri S K Lal, JE and the staff present on the day of inspection could not present complete construction work before him. It is further stated by him that the grant received for the construction was fully utilized on construction work. Further, comments of Superintendent Works were sought on the reply dated 05.02.2018 submitted by the delinquent. In this context, Superintendent Works and S K Lal, JE has intimated that re-inspection was conducted on 12.04.2018 in the presence of Shri Rajesh Kumar and the construction work was assessed of Rs 10,93,664/- against the sanction grant of Rs 10,88,990/-

I have gone through contents of the case and found that charges of financial misappropriation are found not proved against Shri Rajesh Kumar, Principal. Resultantly, charge sheet dated 19.12.2017/04.01.2018 is hereby dropped.

I order accordingly.
