

Whereas Shri Mukesh Kumar, the then Block Elementary Education Officer, Bawal, Rewari now Block Elementary Education Officer, Jatusana [6782] Rewari was charge-sheeted under rule-8 of Haryana Civil Services (P&A) Rule 1987, vide this office order dated 06.09.2012 and the following charges were levelled against him:-



In response to the charge sheet, he has given the reply on 21.09.2012 and denied all the allegations levelled against him. The reply given by him was found unsatisfactory. Therefore, a punishment of stoppage of two increments without cumulative effect was inflicted upon him vide order dated 30.11.2015.

Thereafter, Shri Mukesh Kumar filed an appeal dated 09.12.2015 against the order dated 30.11.2015 before the appellate authority with the request to drop the charge sheet dated 06.09.2012. Accordingly, an opportunity of personal hearing was granted to him on 04.07.2018. During the course of personal hearing he explained that a punishment of stoppage of two increments without commulative effect was inflicted upon him by Director Secondary Education vide order No. 5/65-2012 HRG-I(1)/51 dated 30.11.2015 with regard to appointment of PGT Chemistry (Guest Faculty) in GSSS Rewari in violation of Government Instructions even when a ban was imposed on such appointments. He further explained that he appointed Guest Faculty in accordance with Letter no. 15/59-2005 CO(4) dated 21.07.2008 as Guest Teacher in Government Senior Secondary School where five posts of Lecturer in Chemistry were sanctioned, out of which one post was vacant at that time having total 871 students in Science and Commerce streams in the school. He further narrated that the concerned Block Education Officer, Rewari vide letter no. 1/16/4370 dated 26.07.2016 agreed to the view of Principal, GSSS Rewari that the appointment of Guest Faculty was in accordance with rules as per letter dated 21.07.2008.

In view of the facts and circumstances explained above and after perusing the record available in the file and submissions made by the appellant,  Taking a lenient view in the matter, the punishment of stoppage of two increments without commulative effect inflicted upon him, is hereby set aside for the foregoing reasons.

I order accordingly.

Whereas Shri Sohan Lal [038738], Principal the then Principal, Government Senior Secondary School, Kairiwala (Sirsa) now posted at Government Senior Secondary School, Moju Kheri [2987] (Sirsa) was charge-sheeted under rule-8 of Haryana Civil Services (P&A) Rule 1987, vide this office order dated 06.09.2012 and the following charges were levelled against him:-

In response to the charge sheet, he has given the reply on 25.09.2012 and denied all the allegations levelled against him. The reply given by him was found unsatisfactory. Therefore, a punishment of stoppage of two increments without cumulative effect was inflicted upon him vide order dated 30.11.2015.

Thereafter, Shri Sohan Lal filed an appeal dated 24.12.2015 against the order dated 30.11.2015 before the appellate authority with the request to drop the charge sheet dated 06.09.2012. Accordingly, an opportunity of personal hearing was granted to him on 09.08.2018. During the course of personal hearing he narrated that he was charge sheeted Under Rule 8 for irregularities in appointing Smt Prabhjot Kaur as a Guest Faculty without verification of her eligibility of subject documents. He further stated that he remained DDO of the school for a short period and the appointment of guest teacher was made only for one year considering her interview letter dated 22.09.2006 issued by Haryana Staff Selection Commission which was recommended as she fulfill the qualification of School Teachers Eligibility Test in Home Science through Board of School Education, Bhiwani. He also explained that her appointment was made on the recommendation of committee constituted for the purpose.

In view of the facts and circumstances explained above, the contents of reply of charge sheet and considered the submission of statement made by the appellant and the documents placed on record, I do not find that irregularity had been committed by the appellant officer in appointment of guest teacher. Therefore, I drop the charge sheet and set aside the order dated 30.11.2015.

I order accordingly.



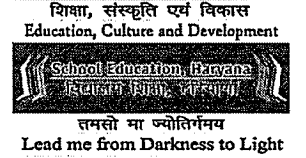


