During the course of personal hearing, he submitted that he complied with the directions of Vigilance Department and never committed any negligence in the directions of Vigilance Department. In this context, I observed that he complied with the directions of Vigilance Department which is a minor deviation and does not constitute a substantial offence.

Hence, I accept the contentions/submissions and file the chargesheet.

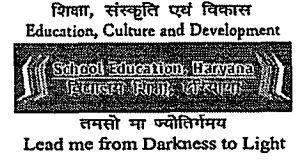
