





Whereas, Shri Jai Singh [032041], Principal, Government Senior Secondary School, Juddi [2614] (Rewari) [now posted at Government Senior Secondary School, Karawara Manakpur [2531], Rewari] was charge sheeted under rule-7 of Haryana Civil Services (Punishment & Appeal) Rule, 1987 on 06.05.2010.

Shri Jai Singh the then Principal, GGSSS Juddi (Rewari) replied to the charge sheet on 26.05.2010. Finding his reply as unsatisfactory, Shri R C Sharma, HCS (Retd) was appointed as Inquiry Officer who submitted his report dated 28.10.2010 and proved the said charges. Thereafter, he was given notice on 07.02.2011 alongwith a copy of the enquiry report to make a representation within a period of one months as provided in Rule 7(6) of Haryana Civil Services (Punishment & Appeal), Rule 1987 and the said incumbent submitted his representation on 04.05.2011 in consequence thereof. Thereafter, taking an overall view of the matter, especially in view of the fact that the charge stand proved, a penalty of stoppage of two increments with cumulative effect was inflicted upon Shri Jai Singh the then Principal, GGSSS Juddi (Rewari) on 21.09.2011.

Whereas Shri Jai Singh the then Principal, GGSSS Juddi (Rewari) filed a Civil Appeal No. 150 of 2015 – Jai Singh V/s DEO Rewari & others decided on 14.02.2017. Further, the operative part of order dated 14.02.2017 is reproduced as under:-

“ It is ordered that the appeal in hand is partly allowed and the impugned judgment and decree passed by the learned lower court is set aside, Consequently, the suit of the appellant-plaintiff is decreed partly and the impugned order dated 21.09.2011, copy of which is Ex. DW-1/B, is hereby declared null and void and accordingly set aside. However, the competent authority is at liberty to proceed further from the stage of serving show cause notice of the proposed penalty upon the appellant-plaintiff and to pass fresh final order as per rules referred to above. Needless to say, anything stated in this judgment shall not be misconstrued as a final opinion on that aspect....”


Accordingly, order dated 20.09.2011 were set aside vide this office order dated 19.12.2017/01.01.2018 in compliance of order dated 14.02.2017 of Hon'ble Court of District Judge, Rewari and fresh show cause notice dated 01.01.2018 was given to Shri Jai Singh, Principal that why the punishment of stoppage of two annual increments with cumulative effect may not be inflicted upon him.

Shri Jai Singh, Principal submitted reply dated 11.01.2018 to show cause notice dated 19.12.2017/01.01.2018 and reiterated the submission made earlier by him. That Shri Jai Singh, Principal was granted an opportunity of personal hearing on 05.07.2018 and the facts mentioned by him in representation dated 11.01.2018 were reiterated by him. It was stated by him that Shri Rakesh Kumar (Guest) was working prior to his joining Govt Sr Sec School, Juddi (Rewari) and no remuneration were paid to him as he was working on honorary basis. It is also stated by him that Shri Rakesh Kumar was relieved from the school as there was ban on

appointment of Guest Teacher. It was specifically pressed by him that no financial loss was caused by him to the State.

Keeping in view the submissions made during personal hearing and the facts of the case, I found no fault on the part of Shri Jai Singh, Principal. Therefore, the Charge-Sheet issued vide No. 5/36-2009 HRG-I(1) dated 06.05.2010 is hereby dropped.

I order accordingly.
