

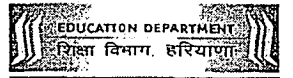

- इसके द्वारा श्रीमती अनिता, लिपिका, [046425] रा0क0व0मा0वि0, खरखौदा, सोनीपत [3469] को सूचित किया जाता है कि संलग्न विवरण में दिये गये आरोपों के आधार पर हरियाणा सिविल सेवा (दण्ड तथा अपील) नियम 2016 के नियम-8 के अन्तर्गत उनके विरुद्ध कार्यवाही करना प्रस्तावित किया गया है। ये आरोप उससे अनुबन्ध अभिकथनों के विवरण पर आधारित हैं।
 - इसके द्वारा श्रीमती अनिता, लिपिका, से उनके द्वारा इस ज्ञापन की प्राप्ति की तिथि से पन्द्रह दिन की अवधि के भीतर लिखित रूप में बताने की अपेक्षा की जाती है कि वे सभी आरोपों या उनमें से किसी को स्वीकार करते हैं या नहीं। उन्होंने क्या स्पष्टीकरण या प्रतिवेदन, यदि कोई हो, प्रस्तुत करना है और क्या वे व्यक्तिगत रूप में अपनी सुनवाई चाहते हैं।
 - इसके द्वारा श्रीमती अनिता, लिपिका को आगे सूचित किया जाता है कि यदि वे अपने लिखित कथन को तैयार करने के प्रयोजन के लिए सुसंगत सरकारी अभिलेखों को देखना चाहते हैं तो उन्हें निदेशक विद्यालय शिक्षा हरियाणा, पंचकुला के कार्यालय में उनके साथ पहले समय नियत करने के बाद, किसी कार्य दिवस को, उनका निरीक्षण कर सकते हैं। फिर भी यह बताया जाता है कि उन्हें केवल ऐसे ही दस्तावेज दिखाये जायेंगे, जोकि निदेशक विद्यालय, शिक्षा हरियाणा, पंचकुला के पास हैं और जो मामलों के साथ पूरी तरह से सुसंगत हैं। यदि सरकार की राय में उन्हें किन्हीं दस्तावेजों को दिखाने की अनुमति देना वांछनीय नहीं है तो उन्हें यह दस्तावेज दिखाने से इन्कार कर दिया जायेगा। यदि श्रीमती अनिता, लिपिका ऐसे किसी अन्य सुसंगत अभिलेख को देखना चाहते हैं जो निदेशक विद्यालय शिक्षा हरियाणा, पंचकुला की अभिरक्षा में नहीं है तो उनका निरीक्षण करने की जिम्मेवारी उनकी अपनी होगी। फिर भी श्रीमती अनिता, लिपिका, रा0क0व0मा0वि0, खरखौदा, सोनीपत को यह बात स्पष्ट की जाती है कि उनके द्वारा उक्त दस्तावेज का निरीक्षण न किया जा सकता उनके लिखित कथन को भेजने में देरी के लिए वैध आधार नहीं माना जायेगा और यदि लिखित कथन निम्नहस्ताक्षरकर्ता को निर्दिष्ट अवधि के भीतर प्राप्त नहीं होता है तो यह समझा जायेगा कि उन्हें इस सम्बन्ध कुछ भी प्रस्तुत नहीं करना है।

श्रीमती अनिता, लिपिका, रा0क0व0मा0वि0, खरखौदा, सोनीपत ने लिपिका के पद पर कार्यरत रहते हुये निम्नलिखित अनियमितताएं की:-

1. यह कि आप द्वारा श्री सज्जन कुमार, संस्कृत प्राध्यापक की सेवापंजी वेतन निर्धारण हेतु जिला शिक्षा अधिकारी, सोनीपत के कार्यालय में ले जाते समय गुम कर दी गई। वर्ष 2009 में सेवापंजी गुम हो गई जिसकी जांच खण्ड शिक्षा अधिकारी व प्राचार्य, रा0क0व0मा0वि0, खरखौदा द्वारा की गई तथा जांच के दौरान पाया गया कि कर्मचारी की सेवापंजी विद्यालय स्तर पर गुम की गई है। विद्यालय के लिपिक पर समस्त स्टाफ सदस्यों एंवम विद्यालय के अन्य रिकार्ड की जिम्मेदारी होती है। अतः प्राध्यापक की सेवापंजी गुम करना उसकी लापरवाही को दर्शाता है और यह कर्मचारी द्वारा जांच के दौरान अपने शपथ पत्र में भी स्वीकार किया है।
