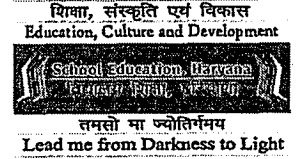

**Terms and conditions:**

1. If any, disciplinary proceeding under Rule 7 of Haryana Civil Services (Punishment & Appeal) Rules, 1987 is found pending subsequently, the said incumbent (s) shall be reverted without issuing any notice.
2. If the currency of penalty of stoppage of grade increments with or without cumulative effect is still in operation, the candidate shall be reverted in view of the CS office instructions dated 31.05.2006, without issuing any notice.
3. The promotion has been given on the basis of availability of 70 percent or more records falling in the category of good or better than that and in the eventuality of finding the integrity doubtful during the said period as well as remaining records, the incumbent (s) shall be reverted without issuing any notice.
4. If subsequently, it is found that any candidates has done Post Graduation or other qualifications in distance mode from deemed Universities from study centers located outside the campuses of the Universities, without seeking approval of UGC and the State Government, then such candidate shall be reverted in view of Division Bench judgment of Punjab and Haryana High court in CWP No. 1640 of 2008 decided on

5. If any discrepancy regarding not fulfilling the essential qualifications as prescribed in the Haryana State Education School Cadre (Group B) Service Rules, 2012, the said incumbent (s) shall be reverted without issuing any notice.
