





Whereas, Sh. Mahavir Singh, PGT Physics, Govt. Sr. Sec. School, Ladwa (Kurukshetra) now Govt. Sr. Sec. School, Pipli (Kurukshetra) was charge sheeted under Rule-7 of Haryana Civil Services (Punishment & Appeals), Rules, 1987 vide Order No. 16/8-2011 PGT-I (1) dated 17.10.2011, wherein the following allegations were levelled against him:-

1. That an amount of Rs. 1,03,686/- and Rs. 25,814/- has been transferred to PTA account and amalgamated fund against Govt. sanction.
2. That Green Glass Board and Chalk Dustless amounting to Rs. 70500/- purchased from 10-04-2008 to 08-12-2008 on different dates has been paid out of sanction of Rs. 2,00,000/- issued vide memo no. 18/5-2008 Sec. Edu(3) dated 10-02-2009, which clearly shows that the amount has been spent by way of credit and paid out of the said sanction for payment to part time teacher, chowkidar, electricity bill, telephone bill and purchase of education material.
3. That neither the approval of the competent authority in excess of authorization has been sought nor proper procedure of financial propriety i.e. constitution of purchase committee etc. has been followed.

Sh. Mahavir Singh submitted his reply to the charge sheet on 03.10.2012 in which he refuted all the charges levelled against him. Thereafter, Sh. R.C. Sharma, HCS (Retd.) was appointed as Inquiry Officer to enquire into the charges levelled against him. The Inquiry Officer after holding regular inquiry submitted its report on 25.11.2013 in which charges mentioned at Sr. No. 1 and 2 of the charge sheet were not proved. Considering the enquiry report submitted by Inquiry Officer the competent authority did not agree with the same and a dissenting note alongwith inquiry report was served upon the charged official on 19.06.2014 for making representation on it. The charged official made a representation with reference to the said dissenting note on 29.05.2017 and requested that he has not committed any irregularity and the dissenting findings to the inquiry report may kindly be dropped.

After, taking into consideration his representation he was afforded an opportunity of personal hearing on 04.07.2018 by the Competent Authority i.e. Additional Chief Secretary to Government of Haryana, School Education Department, Chandigarh. During the hearing he explained that he was charge-sheeted under Rule 7 of HCS (P&A) Rule 1987 for transferring the funds to PTA account and amalgamated fund without approval of Govt. sanction against which the Inquiry Officer has not proved the charges. Thereafter, a Dissenting



Note and Inquiry Report was sent to him and requested that inquiry report be accepted and dissenting findings to the inquiry report may be dropped/withdrawn. He further explained that he has made the payment to part-time teacher, Chowkidar, paid the electricity bill and telephone bill and purchased education material. He further narrated that there was a procedural lapse without any malafide intention on his part which does not constitute a grave misconduct and may be ignored as fund of the school was neither embezzled nor mis-appropriated by him.

In view of the facts and circumstances explained above and after pursuing the inquiry report, list of charges and allegations, report of regular inquiry officer while disagreeing with the findings of the Inquiry Officer as per record available in the file, (~~have found that~~) after taking a lenient view in the matter, he is warned to be careful in future with a recorded warning in his personal file.

I order accordingly.

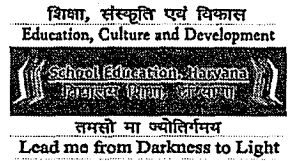

Whereas Shri Vinod Kumar [005558], Block Education Officer, Bhiwani [5513] [now retired on 31.07.2013] was charge-sheeted under rule-8 Haryana Civil Services (P&A) Rule 1987, vide this office order dated 16.08.2011 and the following charges were levelled against him:-

“यह कि श्री विनोद कुमार द्वारा श्रीमती कमलेश, जे0बी0टी0 रा0क0प्रा0पा0 धनाना जिला भिवानी की ग्रामीण क्षेत्र सेवा पूर्ण न होते हुये भी उसकी दिनांक 19.07.2010 से 22.12.2010 तक आंतरिक व्यवस्था शहरी क्षेत्र रा0प्रा0पा0, सैक्टर-13, भिवानी में की जबकि उनकी ग्रामीण क्षेत्र की सेवा पूर्ण नहीं थी, क्योंकि प्रथम नियुक्ति अनुसार कर्मचारी को पांच वर्ष तक नियमानुसार ग्रामीण क्षेत्र में रहना होता है।”

He has given the reply dated 22.09.2011 to the charge sheet and denied the allegations levelled against him. The reply given by him was found unsatisfactory. Therefore, a punishment of stoppage of two increments without cumulative effect was inflicted upon him vide order dated 04.04.2012 after awarding an opportunity by Director Secondary Education, Haryana.

Thereafter, Shri Vinod Kumar filed an appeal dated 21.07.2016 against the order dated 04.04.2012 with request to set aside the order. Resultantly, he was granted an opportunity of personal hearing before the appellate authority on 20.06.2018. During the hearing, he explained that a penalty of stoppage of two increments without cumulative effect be restored due to which he is getting less pension every month due to his retirement on 31.07.2013. The increment due on 01.07.2012 and 01.07.2013 would have been restored on 01.07.2014, had he not retired on 31.07.2013 which is not the spirit of the minor punishment inflicted upon him. Actually this punishment has become a major punishment due to its conversion into the stoppage of increments with cumulative effect because of his date of retirement falling on 31.07.2013, had he remained in service, the same would have been restored. Now, he will suffer the financial loss in perpetuity. He narrated that he was punished for obeying the orders of the then DEO vide letter dated 27.12.2010 and adjusted Smt Kamlesh, JBT, GGPS Dhanana, Bhiwani from rural to an urban station.

In view of the facts and circumstances explained above, I have found that internal adjustment of the incumbent was made by the Appellant due to some administrative exigency in compliance with orders of the then District Education Officer and not at his own level. However, taking a lenient view in the matter, the punishment of stoppage of two increments without cumulative effect inflicted upon him, is hereby set aside for the foregoing reasons.

I order accordingly.
