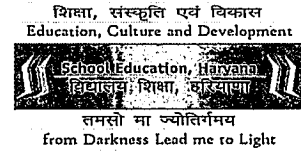

ORDER

Terms and conditions:-

1. The benefit of ante-date appointment w.e.f. 04.05.2017 will be admissible to him/her only for notional pay fixation and seniority and actual financial benefits will be admissible to him/her from the date she joins duty as **PGT Punjabi**.
2. He/She is appointed purely on temporary basis. This appointment is against temporary post and his/her confirmation against substantive post shall be considered on the basis of his/her seniority and record of service as and when such post is available.
3. He/She shall has to take an oath of allegiance to the Constitution of India.
4. In case he/she is married, he/she shall produce a certificate, before joining duty, to the effect that he/she has only one living spouse. If he/she has more than one living spouse, he/she shall be eligible for appointment to the post offered only after the Government is satisfied

that he/she has special ground for doing so, and exempt his/her from this condition.

5. He/She shall not be allowed to apply for any post outside the department for a period of at least five years.
6. He/She shall not claim seniority on the basis of this order. His/her inter-se seniority will also be decided in accordance with the relevant service rules and instructions of the State Government issued from time to time later on.
7. He/She shall be on probation for a period of two years. The period of probation can be extended for a period not exceeding one year, if considered necessary.
8. In the matters, not specifically mentioned in this communication, he/she shall be governed by the Punjab Civil Services Rules as applicable to Haryana Government Employee and such orders/instructions as may be issued by the Government from time to time.
9. In case of reserved category candidate, the appointment is provisional and is subject to verification of the Scheduled Castes/ Scheduled tribes/Backward Class and ESM Category Certificate. If the verification reveals that the claim of belonging to SC/ST/BC and ESM, as the case may be, is false then his/her service will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under provisions of the Indian Penal Code for production of false certificate.
10. Candidate is hereby directed to produce his/her original certificates of academic qualifications, and other relevant certificate to the District Education Officer concerned alongwith photostat self- attested copies. District Education Officer is directed to compare the photo copies with the original and thereafter original certificates and testimonials will be returned to the candidate.
11. Medical fitness certificate issued by the concerned Civil Surgeon will be produced before the joining. District Education Officer will also give character and antecedent verification forms to her and after filling the form, the candidate would submit it to the District Education Officer concerned immediately.

12. He/She shall be governed by the Haryana State Education School Cadre (Group-B) Service Rules-2012.
13. If at any time during the course of his/her temporary appointment, he/she desires to resign, then in such eventuality, he/she shall be required to give one month's notice or forfeit, in lieu thereof, her one month's salary including allowances etc.
14. No TA/DA will be admissible to the candidate for joining as PGT.
15. If he/she gets an appointment as PGT on the basis of his/her furnishing ineligible/invalid qualifications, false/forged or fraudulent information/ facts which are detected later on, he/she would be liable for termination of service without any notice.
16. The appointment will be subject to the final outcome of the civil writ petition No. CWP No. 27479/2016, 26104/2016, 23670/2016, 23550/2016, 17714/2016, 1088/2017, 23265/2016, 24/2017, 27358/2016, 25461/2014, 21006/2015, 305/2017, 231/2017, 50/2017, 1659/2017, 6617/2016 and any other writ petition etc. pending in Hon'ble Punjab and Haryana High Court.
