Whereas, Smt. Santosh Kumari Retired Deputy Director O/o DSE, Haryana Panchkula was charge sheeted under Rule-8 of Haryana Civil Services (P&A), Rules, 1987 vide Order No. 5/105-2016 HRG-I (2), dated 12.10.2017, wherein the following allegation was levelled against her:-

"A meeting was scheduled to be held by the Worthy Additional Chief Secretary School Education, Haryana on 05.04.2016 at 9:30 AM in Conference Hall 6th Floor Shiksha Sadan, Panchkula. Agenda of meeting was also conveyed to Smt. Santosh Kumari vide memo No. PA/JDMG/2016-110 dated 01.04.2016. However, despite adequate notice, she failed to attend the meeting. Even in previous meeting held on 10.02.2016, she did not turn up despite the facts that agenda of this meeting was also conveyed to her vide memo No. 11/62-2015 EE (4) dated 05.02.2016. She also did not submit any reply to the show cause notice issued by the Director, Elementary Education, Haryana, Panchkula.

The aforesaid act and conduct of the Smt. Santosh Kumari clearly indicates that she is habitual to disobey the orders of the higher authority."

Smt. Santosh Kumari, Dy. Director Retd. O/o DSE, Haryana, Panchkula was called for personal hearing on 26.09.2018 at 11:00 AM, Shiksha Sadan, 6th Floor, Sector-5, Panchkula but she did not appear in person before the under signed.

I have gone through the statement of allegation i.e. non-attendance of meeting on 05.04.2016 and also on previous occasion on 10.02.2016 and also other record as available on file.

Since she has already retired from service on superannuation, taking a lenient view and also keeping in view that the charges are not so grave as to warrant punishing her with long lasting consequences. Therefore, charge sheet issued Under Rule-8 of HCS (P&A) Rule, 2016 is, hereby, dropped and it has also been decided that the suspension period of Smt. Santosh Kumari, Deputy Director (Retired) O/o DSE, Haryana Panchkula from 29.04.2016 to 29.09.2016 is treated as duty period for all intents and purposes.



2. The promotion has been given on the basis of availability of 70 percent or more records falling in the category of good or better than that and in the eventuality of finding integrity doubtful during the said period as well as remaining records, the incumbent(s) shall be reverted without issuing any notice.
3. 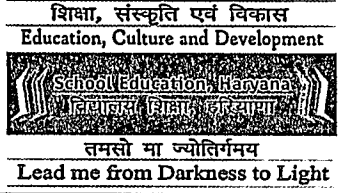

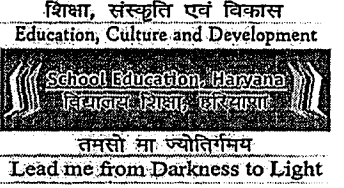

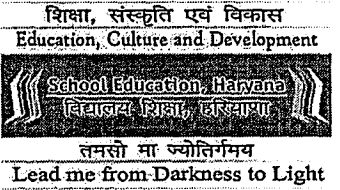
