Whereas Shri Satish Kumar Kaushal [053942] the then Headmaster, Government High School Bunga [3720], Panchkula [now retired on 30.04.2016 as a Principal from Government Senior Secondary School, Sardaheri, Ambala] was charge-sheeted under rule-8 Hayrana Civil Services (P&A) Rule 1987, vide this office order dated 06.09.2012 and the following charges were levelled against him:-

“श्री सतीश कुमार कौशल द्वारा श्रीमती सुदेश रानी को बी०ए० में हिन्दी इलेक्टिव न होते हुए भी दिनांक 12.04.2006 को रा०उ०वि० गुंगा (पंचकूला) में हिन्दी अध्यापिका (अतिथि) के पद पर नियुक्ति प्रदान की।”

In response to the charge sheet dated 06.09.2012, he has given the reply dated 13.09.2012 and denied all the allegations levelled against him. The reply given by him was found unsatisfactory. Therefore, a punishment of stoppage of two increments without cumulative effect was inflicted upon him vide order dated 30.11.2015.

Thereafter, Shri Satish Kumar Kaushal filed an appeal dated 23.12.2015 against the order dated 30.11.2015 with request to withdraw the order dated 30.11.2015. Accordingly, an opportunity of personal hearing was granted to him on 20.06.2018. In view of the above, I have perused the contents of the reply of charge sheet and considered the submission of statements made by the Appellant in view of order dated 20.09.2012 where the Prabhakar examination was considered at PAR with that of Hindi (Elective) of B.A. Examination of Punjab University and allowed her by the Department to continue in service as per order dated 20.09.2012, I do not find any infirmity in appointment of Guest Teacher. Therefore, I drop the charge sheet and set aside the order dated 30.11.2015.



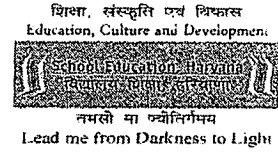
