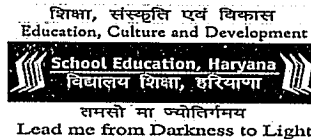

Whereas the petitioner Sh. Ram Mehar Singh, Mali, Govt. Senior Secondary School, Hatt (Jind) approached the Hon'ble High Court by filing CWP No. 26060 of 2012 praying therein that he has been working on the post of Mali on regular basis since 16.06.1993 and junior to him has been promoted to the post of Clerk vide order dated 04.06.2009 under 20% promotion quota in the cadre of Clerks which was to be filled up from eligible Group-D employees having certificate of passing matriculation on the basis of seniority-cum-fitness. The Hon'ble High Court passed the following order on 11.07.2017, which is reproduced as under:-

*"Mr. Doon, learned counsel appearing for the State, submits that in terms of the earlier order, a tentative seniority list of all group 'D' employees in the State (different district cadres), has been prepared on 14.06.2017, pursuant to which objections to the said seniority list were also invited by 30.06.2017, with 81 such objections having been received.*

*He, therefore, seeks a short adjournment to enable the competent authority to consider the said objections and thereafter decide the 'promotion case' of the petitioners and others like them, in terms of the final seniority list to be prepared.*

*Adjourned to 11.10.2017.*

*A copy of this order be placed on the file of the other connected matter too."*

In compliance of the aforesaid order dated 11.07.2017, combined seniority list of the Class-IV has been prepared and the same was uploaded on the website of the department whereby the objections were called and further concerned DEO were directed to send the promotion cases of the eligible Class-IV employees as per seniority.

The brief facts of the case are that the petitioner joined on the post of Mali on 16.06.1993 at Govt. High School, Ratauli (Jind) and thereafter, got himself transferred to present school i.e. Govt. Senior Secondary School, Hatt (Jind) vide order dated 25.05.1998 and joined there on 08.06.1998 by way of losing his earlier seniority. It is submitted that class-IV posts under School Education Department Haryana are an Institutional Cadre posts and when an employee rendering service on this post applies for transfer then, he has to lose his back seniority and the same has been done by the petitioner. Hence, his claim for seniority from 16.06.1993 is not tenable. After transfer, his seniority is to be counted w.e.f. 08.06.1998 and no junior to him has been promoted by the department vide orders dated 04.06.2009. Moreover, the petitioner, being a General Caste employee, compared his seniority with Class-IV employees under Scheduled Caste Employees

who have a special promotion quota of 20%. This claim is also untenable on the basis of reservation quota.


The department has prepared seniority list of Class-IV employees of the State who have matriculation passed certificate in their credit. The name of the petitioner lies at Seniority No. 215. His name has been considered for promotion to post of Clerk but his work and conduct is not found satisfactory and his annual appraisal reports say that he is unsuitable for Class-IV post. The appriaisal report of of petitioner i.e. Sh. Ram Mehar, Mali of the last 10 years is reproduced as under:-

Considering abovesaid appriaisal reports, the petitioner has not been found eligible for promotion to the post of Clerk and accordingly his claim has been rejected and the eligible juniors have been granted promotion vide order dated 14.09.2017.

Considering all the facts on file, I found that the petitioner is not entitled to be granted promotion on the post of Clerk on the basis of his service record/annual appriaisal reports. Therefore, his claim for promotion is hereby rejected.

School, Kheri Khumar [3169] (Jhajjar) has shown laxity in issuance of BPL status to ineligible beneficiaries. He has included ineligible families in BPL list."***

It is also possible that the mistake might have been taken place in the Survey of 2011 instead of 2007 and the Survey of 2011 might have been conducted by some unable person or the family might have not been shown under BPL due to some personal enmity. He was also heard in person on 14.11.2017. He re-iterated the same facts as were given in reply to the charge sheet.

I have gone through the relevant record of the case and submissions made during personal hearing. After taking lenient view, he is warned to be careful in future.

School, Nindana (Rohtak) was posted as Centre Superintendent in Vaish Senior Secondary School, Rohtak in Board of School Education, Haryana exams from 15.09.2008 to 17.09.2008. FIR No. 227 under Section 354 IPC i.e outraging the modesty of a woman was registered in PS Shivaji Colony, Rohtak on 14.11.2008 on the allegation of a girl examinee and he was placed under suspension vide order dated 16.01.2009. Thereafter, he was charge sheeted under Rule 7 vide order dated 19.02.2010 on the following charge/allegation:

“That FIR No. 227 dated 14.11.2008 was registered under Section 354 IPC and an arrested was made on 19.11.2008 and he has not informed the department about his arrest. In this way, he has concealed the facts from the department and hence, made himself a culprit. This conduct of him proves that he has kept the department in dark. Accordingly, he has violated Rule 3 (i), (ii) & (iii) of Haryana Employees Conduct Rules, 1966”.

He replied to the charge-sheet on 10.03.2010. Reply was not found satisfactory, Sh. Vijay Kumar Verma, Joint Director, Prosecution (Retd.) was appointed as Inquiry Officer vide order dated 16.08.2010. The Inquiry Officer submitted his enquiry report on 08.11.2010 vide which no charges as per proved competent authority not agrees with the Enquiry Report. Thereafter, copy of the inquiry report alongwith a dissenting note was sent to Sh. Baljit Singh on 17.02.2011 to make a written representation, if he so desires, within a period of one month from the date of such communication. He made a written representation on 09.03.2011 and an opportunity of personal hearing was given to him.

After hearing in person, the competent authority awarded punishment of stoppage of one increment with cumulative effect vide order dated 01.09.2011 and his suspension period decided vide order dated 25.01.2013.

Aggrieved from order Sh. Baljit Singh (Lecturer Math) file appeal before W/CS and Education Minister against the order dated 01.09.2011 and 25.01.2013 passed by PSSE.

Department submitted the comments, the appellant authority i.e Education Minister. The appellant authority after perusal the record pass the following order "As the case is settled between the parties and also acquitted by the Hon'ble Court. I ordered to release the stopped increment and dues of Sh. Baljit Singh, PGT Mathematics and advised to be censured and careful in future".


