

ORDER

Consequent upon the direction passed by the Hon'ble Supreme Court of India in Civil Appeal No. 4128 of 2012 @ SLP No. 31804 of 2010 and Recommendation of HSSC Panchkula vide their Memo No. HSSC/Conf./Recomm./2015/355 dated 28/09/2015, the Governor of Haryana is pleased to appoint Ms. Pinki Devi D/o Mohinder Singh, R/o Vill. Tehl, PO Bilaspur, Tehsil:Bilaspur, District:Yamuna Nagar- 135102 as Lecturer in Hindi (HES-II) in the pay scale of Rs. 9300-34800+4800 (G.P.) plus usual allowances as admissible under the State Government Rules from time to time with immediate effect. She is directed to join her place of posting mentioned against her names in the mentioned below:-

Terms and conditions:-

1. She is appointed purely on temporary and provisional basis.
2. This appointment is against temporary posts and her confirmation against substantive posts shall be considered on the basis of her seniority and record of service as and when such post is available.
3. She will have to take an oath of allegiance to the Constitution of India.
4. She will produce a certificate before joining the duties to the effect that She has one living spouse in case she is married. If she has not more than one living spouse, she shall be eligible for appointment to the post offered unless the Government after being satisfied that there are special grounds for doing so, exempt her from this condition.
5. She will not be allowed to apply for any post outside the department for a period of at least five years.
6. She will not claim seniority on the basis of this order. Her inter-seniority will also be decided in accordance with the department rules and instructions of the State Government later on.

7. She will be on probation for a period of two years, the period of probation can be extended for a further period not exceeding one year, if considered necessary.
8. In other matters, not specifically mentioned in this communication, She will be governed by the civil services Rules as applicable to Haryana Government Employees and such orders/ instructions as may be issued by the Government from time to time.
9. In case of reserved category candidate, the appointment is provisional and is subject to verification of the Scheduled Castes/ Scheduled tribes/ Backward Class and ESM Category Certificate. If the verification reveals that the claim of belonging to SC/ST/BC and ESM, as the case may be is false, then her services will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under provisions of the Indian Penal Code for production of false certificate.
10. The candidate who has been selected as Lecturer is hereby directed to submit her original certificates of academic qualification and other relevant certificate with the concerned District Education Officer of her place of posting. DEO will ensure that the candidate has submitted a medical fitness certificates duly issued by the Medical Board. Only then she would be allowed to join as Lecturer in respective schools of posting. District Education Officer will also give character and antecedent verification form to her and after filling the form, the candidate would submit the same to the DEO concerned immediately.
11. If the candidate is already in Government job as Class-II officers need not submit a fresh Medical fitness report whereas others are directed to appear before the Medical Board as may be constituted by the Director General Health Services, Haryana, Panchkula and Medical fitness report is to be submitted in the office of the concerned District Education Officer before joining the place of posting as Lecturer in respective Government Senior Secondary School.
12. Her services will be governed by the relevant service rules.
13. If at any time during the course of her temporary appointment, any of the appointee desires to resign, She will be required to give one month's clear notice or forfeit, in lieu thereof, her salary including allowances etc. for one month or for the period by which the notice falls short of one month. Such a notice will be given to her by the Government also in the case it is proposed to terminate her services in lieu thereof the Government will be liable to pay her salary, including allowances for one month or for the period by which the notice falls short of one month.
14. No TA/DA will be admissible to the candidate for joining as Lecturer.

15. If she gets an appointment as Lecturer on the basis of her furnishing false/forged or fraudulent information/ facts which are detected later on, She would be liable for termination of service without any prior notice.
16. If she is willing to accept this offer of appointment as Lecturer, HES-II (School Cadre) on the above terms and conditions, She should submit her joining report as per aforesaid directions.
17. She is directed to join her place of posting during upto 15.12.2015 and send the joining report (duly signed by DDO) at dsehr1123@gmail.com, failing which this offer of appointment letter will be deemed to have been withdrawn.
18. These appointment orders are subject to final outcome of CWP No(s). 15992, 16154, 16493, 16289, 16412, 16413, 161414, 16465, 16228, 16300, 20103, 20058, 21557, 21563, 21874 of 2015 and any other CWP of similar matter pending in the Hon'ble High Court.
