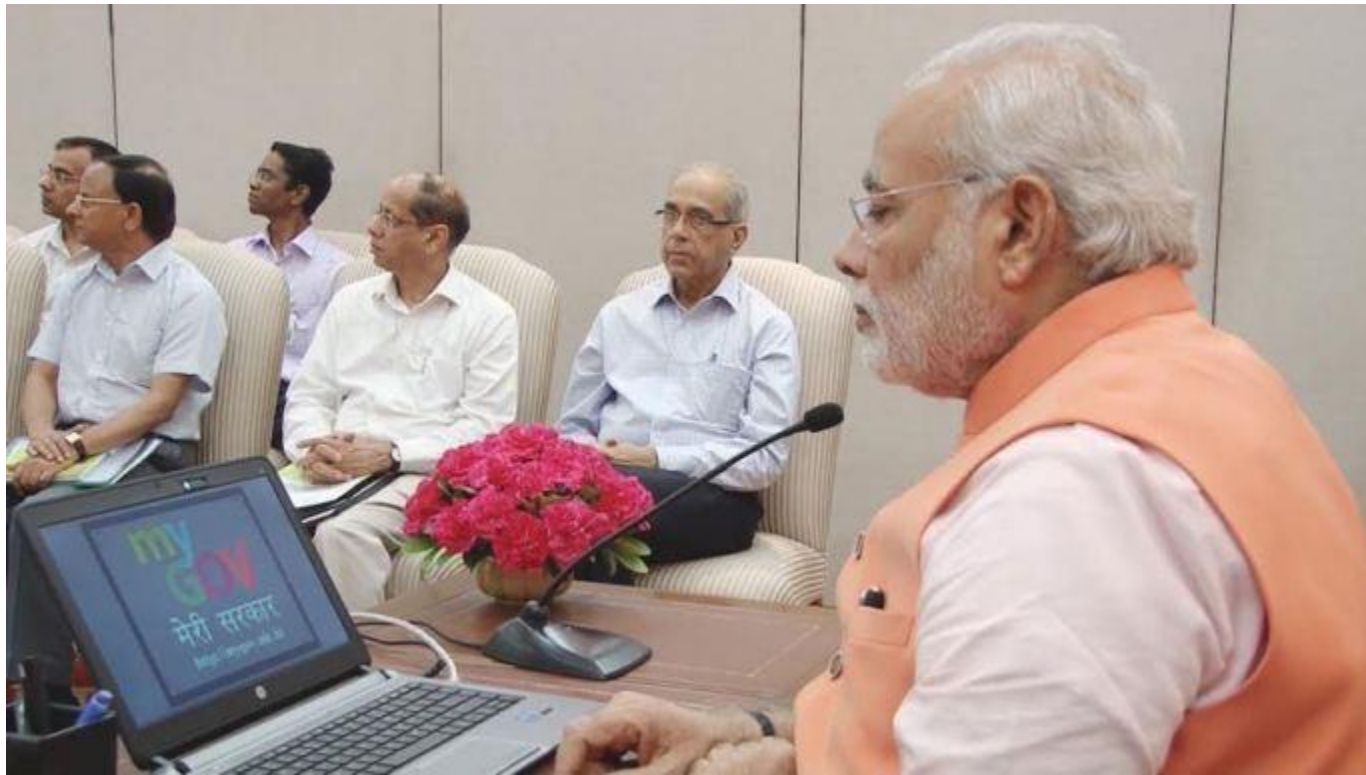

- **Open Access:** No Sign-in to view content
- **MyGov Highlights/In Focus:** highlights of MyGov activities
- **One MyGov One ID:** To Login to all MyGov sub-domains
- **Integration with @gov.in and @nic.in** for Government Officials
- **Hashtags:** Create hashtags to participate in trending discussions
- **Polls:** Online Polls to share opinions on governance
- **MyGov Talks:** Live interaction with decision makers
- **MyGov Podcasts:** Weekly activity wrap-up

# MyGov and New Education Policy

- × Logo, slogan and tagline for New Education Policy crowdsourced
- × 33 thematic topics already under discussion since 26<sup>th</sup> Jan, 2015
- × Over 8,300 Comments received
- × Comments being compiled for MHRD with executive summary and preliminary analysis for finalizing list of actionable items
- × Next step – Preparation for Local Body level consultation
- × Workflow prepared, approval received on 20th March 2015

# Multi-level Consultation – Salient Features

- × Pre-defined questionnaire for Local Bodies - under finalization
- × Software development underway for online submission of local body resolutions in text (in State / UT's Official Language) and images
- × Compilation of local body inputs into district level documents
- × Compilation of district reports into State level documents
- × Webcasting local body meetings
- × Dashboards at all levels for monitoring status of report compilation

# Proposed Workflow

## Gram Panchayat

- Meetings State-wide on a declared date, pass resolutions as per consultation document
- Upload resolution text and images in local language/ English
- @nic.in/@gov.in accounts for GPs in process
- Day for uploading the templates could be predefined at the Block Level

## Block

- CEO/BDO or Secy, BP in-charge
- Aggregation of Gram Panchayat Data and finalise own resolutions

## District

- Single Nodal Officer for each District
- Aggregation of data collected in English

## State

- Nodal Officers - Secretary Higher/Tech Education and School Education
- Monitor and aggregate ULBs and Districts reports and prepare State reports



# Things To Do

- × Appointment of State / District / Block / ULB / GP level nodal officers
- × Instructions to local bodies to deliberate on consultation document and adopt resolutions
- × Issue joint instructions both at Centre and State to local bodies on the workflow
- × Monitoring of Dashboard at State level and by District Collectors
- × Updating Local Government Directory esp. in cases of merging and creation of new local bodies
- × Pre-defining dates for Panchayats to upload resolutions and templates incase of unavailability of internet, District Nodal Officer can facilitate the same
- × Coordination with the Centre on the progress of data collection
- × Coordination with DIOs and SIOs
