



#### Term and conditions of appointment:

- 1. The appointment offered is purely on contract basis which will remain operative upto 31.03.2014 or existence of the Project/Scheme, whichever is earlier & subject to satisfactory performance on a consolidated remuneration of Rupees 25,000/- p.m.
- 2. The contract would be reviewed by the Directorate based on the performance during the contract period and the contract may be rescinded if the performance has been found unsatisfactory before the expiry of contract period.
- 3. The candidate/s will not be entitled to any other benefits except those mentioned above. Moreover, the appointment will be purely under Centrally Sponsored Scheme and strictly liable to co-terminate with the completion of Project/Scheme.
- 4. The services shall come to an end on the expiry of aforesaid contractual period unless extended further by the competent authority. No claim for extension shall be binding on the appointing authority. No right to hold the post shall be conferred upon the candidate/s on account of continuance on the post without any extension by the competent authority and the candidate/s will be relieved of the duties at any time.
- 5. The candidate/s will not be entitled to the salary if wilfully neglect or refuse or from other cause or be unable to perform any of the duties under this project/scheme. If the work and conduct is not found satisfactory or in case candidate/s is/are found guilty of insubordination, intemperance or misconduct or for any other reason, the services will be terminated without giving any notice.
- 6. The contract of appointment can be terminated by the appointing authority by giving a notice of one month without assigning any reason or by giving one month's contractual pay in lieu thereof. If at any stage candidate/s desire to resign from the post, the candidate/s will be required to give one month's clear notice or forfeit in lieu thereof, one month's salary or for the period by which the notice falls short of one month.
- 7. The candidate/s will be entitled to avail total 10 days of Casual Leaves one leave per month on pro-rata basis and no other kind of leave/s will be entitled to. The competent authority may terminate the contract without giving any notice in the event of absence of 7 days or more continuously from duty.
- 8. The candidate/s will perform the duties at the assigned schools. However, could be called upon to perform field duties as and when required by the Director Secondary Education (DSE), Haryana.
- 9. During the period of contract, one shall not be a candidate for election as Member of a Municipal Committee, Municipal Corporation, District Board, Panchayat or any other legislative body.
- 10. The candidate/s shall not take up any part time/full time employment or assignments elsewhere or do any business during the period of the contract with the department.
- 11. One shall stay at the assigned school where one is posted unless on tour.
- 12. The offer of appointment is subject to character and antecedents being certified to be good by two gazette officers of the Government, who, not being relatives, but are known to the candidate/s for the last minimum two years.
- 13. The candidate/s will have to furnish attested copies of certificates in support of date of birth, academic/professional qualifications/experience and Scheduled Caste/ Backward Class etc. (if applicable) before joining the duties. If it is revealed later on that one does not possess prescribed qualifications, experience etc., the appointment shall be cancelled. If the certificates are found to be fake or bogus at





- any later stage, the services shall be terminated forthwith and one may also be liable to criminal action.
